Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Bidders shall quote only those products in the bid which are not obsolete in the market and has a t least **10 years' residual market life** i.e. the offered product shall not be declared end-of-life by t he OEM before this period.
- 2. The installation should be supported with spares for a minimum period of 10 years after successf ul installation and commissioning. "All the spares and consumables required for the equipment shoul d be made available through GeM throughout the agreed supporting period". (A line of confirmation should be submitted along with the bid document.)
- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. Supplier shall ensure that the Invoice is raised in the name of Consigne e with GSTIN of Consignee only.
- 4. **Compliance Sheet and Brochure** of the product(s) offered in the bid, are to be uploaded alon g with the bid documents. In case of any unexplained mismatch of technical parameters, the bid is li able for rejection.
- 5. Experience: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt. Organizat ion / PSU / Public Limited Company for **3 years** before the bid opening date. Copies of relevant contr acts to be submitted along with bid in support of having supplied some quantity during each of the y ear. In case of bunch bids, the primary product having highest value should meet this criterion.
- 6. Scope of Supply (Bid price to include all cost components): Supply Installation Testing Commis sioning of Goods and Training of operators and providing Statutory Clearances required (if any) Insta llation, Commissioning, Testing, Configuration, Training (if any whichever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller at consig nee location free of cost. The payment will be released only thereafter.
- 7. The Seller shall not assign the Contract in whole or part without obtaining the prior written conse nt of buyer.
- 8. Participating bidders should submit OEM Authorization Certificate along with the technical bid do cuments as per **Format-B** given in Buyer uploaded ATC document. One manufacturer can authorize only one agent/dealer.
- 9. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or r emedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: (i) The Seller fails to comply with any material term of the Contract. (ii) The Seller inf orms Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. (iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or def ective Material(s) promptly. (iv) The Seller becomes bankrupt or goes into liquidation. (v) The Seller makes a general assignment for the benefit of creditors. (vi) A receiver is appointed for any substant ial property owned by the Seller. (vii) The Seller has misrepresented to Buyer, acting on which misre presentation Buyer has placed the Purchase Order on the Seller.
- 10. Service & Support: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted. Bidder/OEM must have a Functional Service Centre in the State of each Consig nee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty) . Bidder/OEM must have Dedicated/toll Free Telephone No. for Service Support and provide Escalatio n Matrix of Telephone Numbers for Service Support.

- 11. Bidders are advised to quote prices as per technical specification. However detailed breakup of qu oted prices should be provided in **Price Format-A** uploaded in the prescribed place (Financial Docu ment Required) on online Gem Portal. The prices quoted in the prescribed field on GeM portal will be considered for ranking purpose. Total price quoted in Price Format- A must match with the price quo ted in GeM portal.
- 12. **Delay in Delivery :** If the supplier fails to deliver or install/commission any or all of the goods or fails to perform the services within the time frame(s) incorporated in the Purchase Order/GeM Contra ct, the Buyer shall, without prejudice to other rights and remedies available to the Buyer under the c ontract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, commissioning and/or services until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maxim um is reached, Buyer may consider termination of the contract.
- 13. If any delay by the supplier in maintaining its contractual obligations towards delivery of goods a nd performance of services shall render the supplier liable to any or all of the following sanctions:
 - (a) Imposition of liquidated damages,
 - (b) Forfeiture of its Performance Security and
 - (c) Termination of the Contract for default
- 14. If the item involves software, the successful bidder should obtain software license in the name of 'Director, SCTIMST' and the paper license / email license to be transferred to the name of Institute.
- 15. Malicious Code Certificate: The seller should upload following certificate in the bid: -

(a) This is to certify that the Hardware and the Software being offered, as part of the contract, does n ot contain Embedded Malicious code that would activate procedures to: - (i) Inhibit the desires a nd designed function of the equipment.

- (ii) Cause physical damage to the user or equipment during the exploitation.
- (iii) Tap information resident or transient in the equipment/network.

(b) The firm will be considered to be in breach of the procurement contract, in case of physical dama ge, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) ar e caused due to activation of any such malicious code in embedded software.

- 16. **Performance Bank Guarantee** (if applicable): The successful bidder should furnish a performan ce guarantee/security deposit @ 10 percent of purchase order value for a period of 60 days beyond t he completion of all contractual obligations of the supplier including warranty. Besides ePBG, PBG ca n also be submitted in the form of Bank Guarantee, FD Receipts pledged in the name of Director, SC TIMST or Account Payee Demand Draft drawn from a nationalized bank favoring The Director, SCTIM ST payable at Thiruvananthapuram. - 17. Declaration regarding local content for **Make in India** shall be uploaded along with the bid docu ment.
- 18. Restrictions under Rule 144 (xi) of GFR 2017: Any bidder from a country which shares a lan d border with India will be eligible to participate in this bid only if the bidder is registered with the Co mpetent Authority in accordance with restrictions under Rule 144 (xi) of the General Financial Rules (GFRs) 2017 as amended from time to time. The bidders shall enclose the following certificate along with the bid documents.

- 19. Bidders must ensure that only the concerned document is uploaded in a particular field for docum ent upload. Uploading the same document in multiple fields should be avoided.
- 20. Bidder's offer is liable to be rejected if they do not upload any of the certificates/ documents soug ht in the Bid document, ATC and Corrigendum if any.
- 21. The successful bidder has to register at SCTIMST Vendors' Portal and get themselves verified onc e the purchase order is generated. The payment will be processed only after successful verification o f the seller in the portal.
- 22. Bidder has to demonstrate the equipment Online/ Offline on request.
- 23. Bidder should provide one year subscription support for the software including the modules.
