- 1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Bidders shall quote only those products in the bid which are not obsolete in the market and has at I east 10 years' residual market life i.e. the offered product shall not be declared end-of-life by the O EM before this period.
- 2. The installation should be supported with spares for a minimum period of 10 years after successful i nstallation and commissioning. "All the spares and consumables required for the equipment should be made available through GeM throughout the agreed supporting period". (A line of confirmation should be submitted along with the bid document.)
- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any re sponsibility in this regards. Supplier shall ensure that the Invoice is raised in the name of Consignee wi th GSTIN of Consignee only.
- 4. **Compliance Sheet and Brochure** of the product(s) offered in the bid, are to be uploaded along w ith the bid documents. In case of any unexplained mismatch of technical parameters, the bid is liable fo r rejection.

- 5. **Experience**: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, man ufactured and supplied same or similar Category Products to any Central / State Govt. Organization / P SU / Public Listed Company for **3 years** before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case o f bunch bids, the primary product having highest value should meet this criterion.
- 6. **Scope of Supply** (Bid price to include all cost components): Supply Installation Testing Commissio ning of Goods and Training of operators and providing Statutory Clearances required (if any) Installatio n, Commissioning, Testing, Configuration, Training (if any whichever is applicable as per scope of sup ply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller at consignee locati on free of cost. The payment will be released only thereafter.
- 7. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 8. Participating bidders should submit OEM Authorization Certificate along with the bid documents as per the format given in Buyer uploaded ATC document.
- 9. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or rem edy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: (i) The Seller fails to comply with any material term of the Contract. (ii) The Seller informs Buy er of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or su ch inability otherwise becomes apparent. (iii) The Seller fails to deliver the Material(s) or any part there of within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. (iv) The Seller becomes bankrupt or goes into liquidation. (v) The Seller makes a general assi gnment for the benefit of creditors. (vi) A receiver is appointed for any substantial property owned by the Seller. (vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
- 10. In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.
- 11. **Service & Support**: Bidder/OEM must have a Functional Service Centre in the State of each Consig nee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service centre is not already there at the time of bidding, successful bidder / OEM shall have to establis h one within 30 days of award of contract. Payment shall be released only after submission of documen tary evidence of having Functional Service Centre. BIDDER/OEM must have Dedicated/toll Free Telepho ne No. for Service Support and provide Escalation Matrix of Telephone Numbers for Service Support.
- 12. **Warranty** period of the supplied products shall be **3 years** from the date of final acceptance of goo ds or after completion of installation, commissioning & testing of goods (if included in the scope of sup ply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the ti me of delivery of Goods. The seller should guarantee the rectification of goods in case of any break do wn during the guarantee period. Seller should have well established Installation, Commissioning, Traini ng, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Detai Is of Service Centres near consignee destinations are to be uploaded along with the bid.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the

bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
