- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 2. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. - 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. - 8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Bidders shall quote only those products in the bid which are not obsolete in the market and has at lea st 10 years' residual market life i.e. the offered product shall not be declared end-of-life by the OEM b efore this period.
- 2. The installation should be supported with spares for a minimum period of 10 years after successful in stallation and commissioning. "All the spares and consumables required for the equipment should be made available through GeM throughout the agreed supporting period". (A line of confirmation should be submitted along with the bid document.)
- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
- 4. **Compliance Sheet and Brochure** of the product(s) offered in the bid, are to be uploaded along wit h the bid documents. In case of any unexplained mismatch of technical parameters, the bid is liable fo r rejection.
- 5. **Experience**: The Bidder or its OEM (themselves or through resellers) should have regularly, manufac tured and supplied same or similar Category Products to any Central / State Govt. Organization / PSU / Public Listed Company for **3 years** before the bid opening date. Copies of relevant contracts to be su bmitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

- 6. **Scope of Supply** (Bid price to include all cost components): Supply Installation Testing Commissioni ng of Goods and Training of operators and providing Statutory Clearances required (if any) Installation , Commissioning, Testing, Configuration, Training (if any whichever is applicable as per scope of sup ply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller at consignee loca tion free of cost. The payment will be released only thereafter.
- 7. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 8. Participating bidders should submit **OEM Authorization Certificate** along with the bid documents a s per the format given in Buyer uploaded ATC document.
- 9. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remed y available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: (i) The Seller fails to comply with any material term of the Contract. (ii) The Seller informs Bu yer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. (iii) The Seller fails to deliver the Material(s) or any part the ereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. (iv) The Seller becomes bankrupt or goes into liquidation. (v) The Seller makes a general assignment for the benefit of creditors. (vi) A receiver is appointed for any substantial property owned by the Seller. (vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer h as placed the Purchase Order on the Seller.
- 10. In case of imported products, OEM or Authorized Seller of OEM should have a registered office in Indi a to provide after sales service support in India. The certificate to this effect should be submitted.
- 11. **Service & Support**: Bidder/OEM must have a Functional Service Centre in the State of each Consign ee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service centre is not already there at the time of bidding, successful bidder / OEM shall have to establi sh one within 30 days of award of contract. Payment shall be released only after submission of docum entary evidence of having Functional Service Centre. BIDDER/OEM must have Dedicated/toll Free Tele phone No. for Service Support and provide Escalation Matrix of Telephone Numbers for Service Support.
- 12. **Warranty** period of the supplied products shall be a minimum of **3 Years** from the date of final acce ptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
- 13. The Three Year warranty sought for is OEM free warranty without any additional cost towards extend ed warranty to fulfil the tender condition. The charges, if any, claimed by the bidder towards warranty in this regard and included in the product cost in Price Format-A should be mentioned in the Price Format-D also. This warranty charges shall not be considered for calculating actual CAMC value to be payable after warranty period. Where the total cost does not include such warranty charges, the bidder shall submit a declaration to this effect along with the Technical Bid in Format-G. False declaration may lead to rejection of bid. In the case of Indian Agent representing foreign OEM, the bidder shall also liable to furnish Proforma Invoice from the OEM (Foreign Principals) indicating the nature of after sales service including warranty conditions.
- 14. Successful bidder will have to ensure that adequate number of dedicated technical service personals/ engineers are designated/deployed for attending to the Service Request in a time bound manner and f or ensuring Timely Servicing/rectification of defects during warranty period, as per Service level agree ment indicated in the relevant clause of the bid. After having been notified of the defects/service requi rement during warranty period, Seller has to complete the required Service/Rectification within 3 days 'time limit. If the Seller fails to complete service/rectification with defined time limit, a penalty of 0.5 % of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all s uch penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more th an 10% of the total contract value after which the Buyer shall have the right to get the service/rectific ation done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service/rectification to the Buyer.
- 15. Performance (during Warranty period): The time spent on the repair work will be added to the warran ty period of the equipment.
- 16. **Comprehensive Annual Maintenance Contract (CAMC)**: The maximum permissible CAMC charg es after warranty period shall be 5% of the cost of the equipment. The CAMC charges shall be quoted in percentage rate in GeM Bid. This CAMC charges at Net Present Value shall be taken into account fo r arriving the lowest responsive bidder. The year-wise rate percentage of CAMC quoted in the bid for L

1 evaluation shall be used for calculating the actual CAMC value. The actual AMC charges have to be quoted in INR (excluding GST) in Format-E. Escalation of maximum 5% will be allowed after every thre e years of CAMC. The 'Cost of the equipment for CAMC/AMC calculation' shall not include additional w arranty cost (if any), cost towards Installation, Commissioning and Testing (in addition to the original equipment cost of the OEM), cost of transportation including import customs duty in the case of fully finished imported goods quoted in INR, specific excluded items from CAMC/AMC as per the tender condition and also GST, if any, included in the Total cost (Ref. Format-D).

- 17. **Annual Maintenance Contract (AMC) Labour**: The Labour AMC charges shall be maximum 2.5% of 'Cost of the equipment for CAMC/AMC calculation' as given in Format-D. The actual AMC charges h ave to be quoted in INR (excluding GST) in Format-F. Escalation of maximum 5% will be allowed after every three years of AMC. The 'Cost of the equipment for CAMC/AMC calculation' shall not include add itional warranty cost (if any), cost towards Installation, Commissioning and Testing (in addition to the original equipment cost of the OEM), cost of transportation including import customs duty in the case of fully finished imported goods quoted in INR, specific excluded items from CAMC/AMC as per the ten der condition and also GST, if any, included in the Total cost (Ref. Format-D).
- 18. The successful bidder shall enter into CAMC/AMC as chosen by SCTIMST, three months prior to the co mpletion of warranty period. The CAMC/AMC will commence after the date of expiry of warranty period from the date specified in the work order and agreement executed in this regard, which will be treated as the first year of CAMC/AMC.
- 19. Performance (during CAMC period): Uptime means 98 percent on 24 (hrs) X 7 (days) X 365 (days) ba sis, with penalty, to extend CMC period by double the downtime period. Down time means any shorta ge in achieving the up-time.
- 20. Penalty during AMC/CAMC period will be applicable as per prevailing Rules of SCTIMST as amended fr om time to time.
- 21. The seller shall enclose copies of Purchase Orders for the supply of same of or similar equipment issu ed by National Institutes/Universities and Performance Certificates along with technical bid documents
- 22. **List of Essential Spares & Consumables**: If the equipment contains any essential spares and con sumables, the price shall be frozen for a minimum period of 3 years after warranty period. The price of the spares and consumables shall be submitted in Format-B and Format-C respectively. This is for the purpose of price freezing only. However, the bid price shall be inclusive and the equipment be supplied with all essential spares and accessories as per standard delivery and normal functioning of the machine.
- 23. If the item involves software, the successful bidder should obtain software license in the name of 'Dir ector, SCTIMST' and the paper license / email license to be transferred to the name of Institute.
- 24. Malicious Code Certificate: The seller should upload following certificate in the bid:
 - a. This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to: (i) Inhibit the desires and desi gned function of the equipment, (ii) Cause physical damage to the user or equipment during the exp loitation, (iii) Tap information resident or transient in the equipment/network.
 - b. The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are ca used due to activation of any such malicious code in embedded software.
- 25. **Performance Bank Guarantee**: The successful bidder shall furnish a performance guarantee/secur ity deposit @ 10 percent of purchase order value for a period of 60 days beyond the completion of all contractual obligations of the supplier including warranty. The PBG format is available in the Buyer upl oaded ATC Document. Hard copies of PBG in original shall reach the office of "The Sr. Purchase & Stor es Officer, Biomedical Technology Wing, SCTIMST, Satelmond Palace, Poojappura, Thiruvananthapura m, Kerala 695012" the buyer within 15 days of award of contract.
- 26. **Earnest Money Deposit (EMD)**: EMD can be submitted in the form of Account Payee Demand Draft drawn in any a nationalized bank favoring The Director, SCTIMST payable at Thiruvananthapuram. The hard copy of EMD should reach the office of "The Sr. Purchase & Stores Officer, Biomedical Technology Wing, SCTIMST, Satelmond Palace, Poojappura, Thiruvananthapuram, Kerala 695012" within 5 working days from the closing date of the bid failing which the bid will summarily be rejected.
- 27. **Restrictions under Rule 144 (xi) of GFR 2017**: Any bidder from a country which shares a land bo rder with India will be eligible to participate in this bid only if the bidder is registered with the Compet ent Authority in accordance with restrictions under Rule 144 (xi) of the General Financial Rules (GFRs) 2017 as amended from time to time. The bidders shall enclose the following certificate along with the bid documents.

[&]quot;I have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; I certify that this vendor/bidder is not from such a country or, if from such a country,

- 28. **Liquidated Damages**: If the supplier fails to deliver or install/commission any or all of the goods or f ails to perform the services within the time frame(s) incorporated in the Purchase Order/GeM Contract, the Buyer shall, without prejudice to other rights and remedies available to the Buyer under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of del ay or part thereof on delayed supply of goods, installation, commissioning and/or services until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is rea ched, Buyer may consider termination of the contract.
- 29. If any delay by the supplier in maintaining its contractual obligations towards delivery of goods and p erformance of services shall render the supplier liable to any or all of the following sanctions: (a) Impo sition of liquidated damages, (b) Forfeiture of its Performance Security and (c) Termination of the Cont ract for default
- 30. Bidders must ensure that only the concerned document is uploaded in a particular field for document upload. Uploading the same document in multiple fields should be avoided.
- 31. **Documents to be uploaded in Financial Document sought for**: The bidders shall upload Forma ts A,B,C,D,E,F&G mandatorily against the 'Financial Document' sought for in the bid document. The formats are available in the Buyer uploaded ATC document.
- 32. Bidder's offer is liable to be rejected if they do not upload any of the certificates/ documents sought in the Bid document, ATC and Corrigendum if any.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 1.CMC shall include preventive maintenance including calibration as per technical/ service /operational manual of the manufacturer, service charges and spares, after satisfactory completion of Warranty. During the CMC period commencing from date of the successful completion of warranty period, Service personnel shall visit each consignee site as recommended in the manufacturer's technical/ service /operational manual, at least once in six months or as per user requirement. Cost of consumables shall not be included in CMC.Further there will be 98% uptime warranty during CMC period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend CMC period by double the downtime period.
- 2.CMC charges to be indicated as percentage of cost of equipment quoted for each year after the warranty period.
- 3.GST shall be included in the CMC Charges quoted.
- 4.Cost of CMC will be added for Ranking/Evaluation purpose with depreciation formula.A 10% discounting rate per year shall be applied on CMC Charges for price evaluation on Net Present Value.
- 5. The payment of CMC will be made on quarterly basis after satisfactory completion of said period, duly certified by end user.
- 6.While creating a bid or RA, buyers shall indicate whether CMC is required against Yes/No" options. If CMC Charges are included, an option for number of years for CMC required after the warranty period shall be available. Under this option up to 10 years can be chosen for CMC charges beyond warranty period.

 7.In case the bid has a provision for CMC, the warranty of the product will also be deemed to have been converted into Comprehensive warranty including preventive maintenance and calibration as per technical/ service /operational manual of the manufacturer, service charges and spares, during the Warranty Period also. - 8.4.CMC charges offered for each subsequent year should be same or higher than preceding year.
- 8.5. The CMC charges shall be offered within range of 3 to 10% of cost of equipment.

- 9. Since CMC charges are to be paid only later for each year during CMC period, applicable performance guarantee amount after placement of contract shall be based on the cost of equipment excluding the cost of CMC Charges.

- 12.The CMC Contract shall be an offline contract to be handled by buyer. The payment of CMC will be made on quarterly basis after satisfactory completion of said period, duly certified by end user and scope of CMC will be as per para 1 above.
- 13.CMC Charges are inclusive of all the charges for Transportation, Lodging, Boarding, all insurances including third party insurance and all other incidental charges. The same shall include GST. The prices also include cost of spares and damaged parts. Purchaser does not have any liability, whatsoever, over and above the cost of CMC. It also includes for arranging hand tools & tackles, special tools etc. required to carry out the work.
