The bidder seeking exemption from Experience Criteria, shall upload the supporting

- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. - 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 10 y
  ears' residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this perio
  d.
- The installation should be supported with spares for a minimum period of 10 years after successful installatio
  n and commissioning. "All the spares and consumables required for the equipment should be made available t
  hrough GeM throughout the agreed supporting period". (A line of confirmation should be submitted along with
  the bid document.)
- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
- 4. **Compliance Sheet and Brochure** of the product(s) offered in the bid, are to be uploaded along with the bid documents. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.
- 5. **Experience**: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt. Organization / PSU / Public Listed Company for **3 years** before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.
- 6. Scope of Supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Go ods and Training of operators and providing Statutory Clearances required (if any) Installation, Commissioning, Testing, Configuration, Training (if any whichever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller at consignee location free of cost. The payment will be released only thereafter.
- 7. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

- 8. Participating bidders should submit**OEM Authorization Certificate** along with the bid documents as per th e format given in Buyer uploaded ATC document.
- 9. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy availa ble to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: (i) The Seller fails to comply with any material term of the Contract. (ii) The Seller informs Buyer of its inability to deli ver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise become s apparent. (iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery P eriod and/or to replace/rectify any rejected or defective Material(s) promptly. (iv) The Seller becomes bankrup t or goes into liquidation. (v) The Seller makes a general assignment for the benefit of creditors. (vi) A receive r is appointed for any substantial property owned by the Seller. (vii) The Seller has misrepresented to Buyer, a cting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
- 10. In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provi de after sales service support in India. The certificate to this effect should be submitted.
- 11. **Service & Support**: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Loca tion in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service centre is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functi onal Service Centre. BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support and provid e Escalation Matrix of Telephone Numbers for Service Support.
- 12. The bidder should submit a declaration confirming that the Product Cost/Total Cost does not include warranty charges other than OEM Warranty. If any charges claimed by the bidder towards Three Years warranty which i s included in the Product Cost / Total Cost, this fact shall be mentioned in the declaration form. Aforesaid decl aration should be submitted along with the technical bid. The warranty (3 years) sought for the equipment is f ree warranty without any additional cost towards extended warranty and if any warranty cost is included in the equipment cost for complying with the tender condition, the same shall not be considered for arriving CAMC value. The split-up of warranty cost (if any included in product cost) shall be provided (year wise) by the bidde r in the financial document sought for. The proforma is available in the Buyer uploaded ATC document.
- 13. Successful bidder will have to ensure that adequate number of dedicated technical service personals/engineer s are designated/deployed for attending to the Service Request in a time bound manner and for ensuring Tim ely Servicing/rectification of defects during warranty period, as per Service level agreement indicated in the re levant clause of the bid. After having been notified of the defects/service requirement during warranty period, Seller has to complete the required Service/Rectification within 3 days' time limit. If the Seller fails to complet e service/rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service/rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service/rectification to the Buyer.
- 14. Performance (during Warranty period): The time spent on the repair work will be added to the warranty period of the equipment.
- 15. Performance (during CAMC period): Uptime means 95 percent of total days in a year during which the equipm ent remains functional. Down time means any shortage in achieving the up-time. Down time attracts penalty.
- 16. Penalty during AMC/CAMC period will be applicable as per prevailing Rules of SCTIMST as amended from time to time.
- 17. User list: The bidder shall submit the user list of National Institutes/Govt.Organisation in India along with the bid for verifying the performance of the equipment as well as after sale service.
- 18. **List of Essential Spares & Consumables**: If the equipment contains any essential spares and consumables , the price shall be frozen for a minimum period of 3 years after warranty period. The price of the spares and c onsumables should be submitted separately by the bidder in the financial document sought for. The format is available in the Buyer uploaded ATC document. This is for the purpose of price freezing only. However, the bid price shall be inclusive and the equipment be supplied with all essential spares and accessories as per standar d delivery and normal functioning of the machine.
- 19. If the item involves software, the successful bidder should obtain software license in the name of 'Director, SC TIMST' and the paper license / email license to be transferred to the name of Institute.
- 20. Malicious Code Certificate: The seller should upload following certificate in the bid:
  - a. This is to certify that the Hardware and the Software being offered, as part of the contract, does not c

- ontain Embedded Malicious code that would activate procedures to: (i) Inhibit the desires and design ed function of the equipment, (ii) Cause physical damage to the user or equipment during the exploita tion, (iii) Tap information resident or transient in the equipment/network.
- b. The firm will be considered to be in breach of the procurement contract, in case physical damage, los s of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.
- 21. **Performance Bank Guarantee**: The successful bidder should furnish a performance guarantee/security dep osit @ 5 percent of purchase order value for a period of 60 days beyond the completion of all contractual oblig ations of the supplier including warranty. Besides ePBG, PBG can also be submitted in the form of Bank Guara ntee, FD Receipts pledged in the name of Director, SCTIMST or Account Payee Demand Draft drawn from a nat ionalized bank favoring The Director, SCTIMST payable at Thiruvananthapuram. The PBG format is shown in the Buyer uploaded ATC Document. Hard copies of PBG in original should reach the buyer within 15 days of awa rd of contract.
- 22. **Restrictions under Rule 144 (xi) of GFR 2017**: Any bidder from a country which shares a land border with India will be eligible to participate in this bid only if the bidder is registered with the Competent Authority in a ccordance with restrictions under Rule 144 (xi) of the General Financial Rules (GFRs) 2017 as amended from ti me to time. The bidders shall enclose the following certificate along with the bid documents. "I have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; I certify that this vendor/bidder is not from such a country or, if from such a country, has been registered with the Competent Authority. I hereby certify that this vendor/bidder fulfills all requirements in this regard and is eligible to be considered for procurement from GeM. [Where applicable, evidence of valid registration by the C ompetent Authority shall be attached]."
- 23. Liquidated Damages: If the supplier fails to deliver or install/commission any or all of the goods or fails to p erform the services within the time frame(s) incorporated in the Purchase Order/GeM Contract, the Buyer shal I, without prejudice to other rights and remedies available to the Buyer under the contract, deduct from the c ontract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed s upply of goods, installation, commissioning and/or services until actual delivery or performance subject to a m aximum of 10% of the contract price. Once the maximum is reached, Buyer may consider termination of the c ontract.
- 24. If any delay by the supplier in maintaining its contractual obligations towards delivery of goods and performan ce of services shall render the supplier liable to any or all of the following sanctions: (a) Imposition of liquidate d damages, (b) Forfeiture of its Performance Security and (c) Termination of the Contract for default
- 25. Bidders must ensure that only the concerned document is uploaded in a particular field for document upload.

  Uploading the same document in multiple fields should be avoided.
- 26. Bidder's offer is liable to be rejected if they do not upload any of the certificates/ documents sought in the Bid document, ATC and Corrigendum if any.
- 27. Item should be supplied only on FOR Destination Basis (inclusive of unloading charges). Unloading charges nee d to be borne by supplier only.
