Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 10 years' residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.
- 2. The installation should be supported with spares for a minimum period of 1 0 years after successful installation and commissioning. "All the spares and consumables required for the equipment should be made available through GeM throughout the agreed supporting period". (A line of confirmation

- should be submitted along with the bid document.)
- 3. Bidders are advised to check applicable GST on their own before quoting. B uyer will not take any responsibility in this regards. Supplier shall ensure th at the Invoice is raised in the name of Consignee with GSTIN of Consignee o nly.
- 4. **Compliance Sheet and Brochure** of the product(s) offered in the bid, ar e to be uploaded along with the bid documents. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.
- 5. **Scope of Supply** (Bid price to include all cost components): Supply Install ation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any) Installation, Commissioning, Testing, Configuration, Training (if any whichever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorized Reseller at consignee location free of cost. Item should be supplied only on FOR Destination Basis (Inclusive of unloading charges). Unloading charges need to be borne by supplier only. The payment will be released only thereafter.
- 6. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 7. Participating bidders should submit **OEM Authorization Certificate** alon g with the bid documents as per the format given in Buyer uploaded ATC do cument.
- 8. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: (i) The Seller fails to comply with any material term of the Contract. (ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. (iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. (iv) The Seller becomes bankrupt or goes into liquidation. (v) The Seller makes a general assignment for the benefit of creditors. (vi) A receiver is appointed for any substantial property owned by the Seller. (vii) The Seller has misrepresented to Buyer, acting on which misre presentation Buyer has placed the Purchase Order on the Seller.
- 9. In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.
- 10. Service & Support: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not ap plicable in case of goods having on-site warranty). If service centre is not al ready there at the time of bidding, successful bidder / OEM shall have to est ablish one within 30 days of award of contract. Payment shall be released o nly after submission of documentary evidence of having Functional Service Centre. BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support and provide Escalation Matrix of Telephone Numbers for Service Support.
- 11. The bidder should submit a declaration confirming that the Product Cost/Total Cost does not include warranty charges other than OEM Warrant y. If any charges claimed by the bidder towards Three Years warranty which is included in the Product Cost / Total Cost, this fact shall be mentioned in t

- he declaration form. Aforesaid declaration should be submitted along with the technical bid. The warranty (3 years) sought for the equipment is free warranty without any additional cost towards extended warranty and if any warranty cost is included in the equipment cost for complying with the tender condition, the same shall not be considered for arriving CAMC value. The split-up of warranty cost (if any included in product cost) shall be provided (year wise) by the bidder in the financial document sought for. The proforma is available in the Buyer uploaded ATC document.
- 12. Successful bidder will have to ensure that adequate number of dedicated t echnical service personals/engineers are designated/deployed for attending to the Service Reguest in a time bound manner and for ensuring Timely Ser vicing/rectification of defects during warranty period, as per Service level a greement indicated in the relevant clause of the bid. After having been notif ied of the defects/service requirement during warranty period, Seller has to complete the required Service/Rectification within 3 days' time limit. If the S eller fails to complete service/rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each we ek of delay from the seller. Seller can deposit the penalty with the Buyer dir ectly else the Buyer shall have a right to recover all such penalty amount fr om the Performance Security (PBG). Cumulative Penalty cannot exceed mor e than 10% of the total contract value after which the Buyer shall have the right to get the service/rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reim burse the cost of such service/rectification to the Buyer.
- 13. Performance (during Warranty period): The time spent on the repair work will be added to the warranty period of the equipment.
- 14. **Restrictions under Rule 144 (xi) of GFR 2017**: Any bidder from a coun try which shares a land border with India will be eligible to participate in thi s bid only if the bidder is registered with the Competent Authority in accord ance with restrictions under Rule 144 (xi) of the General Financial Rules (GF Rs) 2017 as amended from time to time. The bidders shall enclose the follo wing certificate along with the bid documents. "I have read the clause regar ding restrictions on procurement from a bidder of a country which shares a land border with India; I certify that this vendor/bidder is not from such a country or, if from such a country, has been registered with the Competent Au thority. I hereby certify that this vendor/bidder fulfills all requirements in this regard and is eligible to be considered for procurement from GeM. [Where applicable, evidence of valid registration by the Competent Authority shall be attached]."
- 15. **Liquidated Damages**: If the supplier fails to deliver or install/commission any or all of the goods or fails to perform the services within the time frame (s) incorporated in the Purchase Order/GeM Contract, the Buyer shall, witho ut prejudice to other rights and remedies available to the Buyer under the c ontract, deduct from the contract price, as liquidated damages, a sum equi valent to 0.5% per week of delay or part thereof on delayed supply of goods , installation, commissioning and/or services until actual delivery or perform ance subject to a maximum of 10% of the contract price. Once the maximum is reached, Buyer may consider termination of the contract.
- 16. If any delay by the supplier in maintaining its contractual obligations towar ds delivery of goods and performance of services shall render the supplier li able to any or all of the following sanctions: (a) Imposition of liquidated dam

- ages, (b) Forfeiture of its Performance Security and (c) Termination of the C ontract for default
- 17. Bidders must ensure that only the concerned document is uploaded in a p articular field for document upload. Uploading the same document in multiple fields should be avoided.
- 18. Bidder's offer is liable to be rejected if they do not upload any of the certificates/ documents sought in the Bid document, ATC and Corrigendum if any.
