The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- 1. Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 10 years' residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.
- 2. The installation should be supported with spares for a minimum period of 10 years after successful installation and comm issioning. - 12. The bidder should submit a declaration confirming that the Product Cost/Total Cost does not include warranty charges oth er than OEM Warranty. If any charges claimed by the bidder towards Three Years warranty which is included in the Product Cost / Total Cost, this fact shall be mentioned in the declaration form. Aforesaid declaration should be submitted along with the technical bid. The warranty (3 years) sought for the equipment is free warranty without any additional cost towards extended warranty and if any warranty cost is included in the equipment cost for complying with the tender condition, the same shall not be considered for arriving CAMC value. The split-up of warranty cost (if any included in product cost) shall be provided (year wise) by the bidder in the financial document sought for. The proforma is available in the Buyer uploaded ATC document.
- 13. Successful bidder will have to ensure that adequate number of dedicated technical service personals/engineers are desig nated/deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing/rectificati on of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid. After hav ing been notified of the defects/service requirement during warranty period, Seller has to complete the required Service/R ectification within 3 days' time limit.
- 14. **Delay in Delivery**: If the Seller fails to complete service/rectification with defined time limit, a penalty of 0.5% of Unit Pri ce of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service/rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service/rectification to the Buyer.
- 15. User list : The bidder shall submit the user list of National Institutes/Govt.Organisation in India along with the bid for verif ying the performance of the equipment as well as after sale service.
- 16. If the item involves software, the successful bidder should obtain software license in the name of 'Director, SCTIMST' and the paper license / email license to be transferred to the name of Institute.
- 17. Malicious Code Certificate: The seller should upload following certificate in the bid:
 - a. This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Emb edded Malicious code that would activate procedures to: (i) Inhibit the desires and designed function of the equipment, (ii) Cause physical damage to the user or equipment during the exploitation, (iii) Tap information resi dent or transient in the equipment/network.
 - b. The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of inform ation or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of a ny such malicious code in embedded software.
- 18. **Restrictions under Rule 144 (xi) of GFR 2017**: Any bidder from a country which shares a land border with India will be eligible to participate in this bid only if the bidder is registered with the Competent Authority in accordance with restrictio ns under Rule 144 (xi) of the General Financial Rules (GFRs) 2017 as amended from time to time. The bidders shall enclo se the following certificate along with the bid documents. "I have read the clause regarding restrictions on procurement f rom a bidder of a country which shares a land border with India; I certify that this vendor/bidder is not from such a country y or, if from such a country, has been registered with the Competent Authority. I hereby certify that this vendor/bidder ful fills all requirements in this regard and is eligible to be considered for procurement from GeM. [Where applicable, evidence of valid registration by the Competent Authority shall be attached]."
- 19. Liquidated Damages: If the supplier fails to deliver or install/commission any or all of the goods or fails to perform the s

ervices within the time frame(s) incorporated in the Purchase Order/GeM Contract, the Buyer shall, without prejudice to o ther rights and remedies available to the Buyer under the contract, deduct from the contract price, as liquidated damage s, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, commissioning and /or services until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum i s reached, Buyer may consider termination of the contract.

- 20. If any delay by the supplier in maintaining its contractual obligations towards delivery of goods and performance of servic es shall render the supplier liable to any or all of the following sanctions: (a) Imposition of liquidated damages, (b) Forfeit ure of its Performance Security and (c) Termination of the Contract for default
- 21. Bidders must ensure that only the concerned document is uploaded in a particular field for document upload. Uploading the same document in multiple fields should be avoided.
- 22. Bidder's offer is liable to be rejected if they do not upload any of the certificates/ documents sought in the Bid document, ATC and Corrigendum if any.
- 23. Item should be supplied only on FOR Destination Basis (inclusive of unloading charges). Unloading charges need to be bo rne by supplier only.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
