1. 5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 10 years' residu al market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.
- 2. The installation should be supported with spares for a minimum period of 10 years after successful installation and com missioning. "All the spares and consumables required for the equipment should be made available through GeM throughout the agreed supporting period". (A line of confirmation should be submitted along with the bid document.)
- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
- 4. **Compliance Sheet and Brochure** of the product(s) offered in the bid, are to be uploaded along with the bid documents. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.
- 5. **Experience**: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt. Organization / PSU / Public Listed Company for **3 years** bef ore the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some q uantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.
- 6. Scope of Supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods and Trai

ning of operators and providing Statutory Clearances required (if any) Installation, Commissioning, Testing, Configuration, T raining (if any - whichever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller at consignee location free of cost. The payment will be released only thereafter.

- 7. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 8. Participating bidders should submit **OEM Authorization Certificate** (Annexure-I) along with the bid documents as per th e format given in Buyer uploaded ATC document.
- 9. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if: (i) The Seller fails to comply with any material term of the Contract. (ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. (iii) The Seller fails to deliver the Material (s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent. (iii) The Seller fails to deliver the Materia al(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material (s) promptly. (iv) The Seller becomes bankrupt or goes into liquidation. (v) The Seller makes a general assignment for the b enefit of creditors. (vi) A receiver is appointed for any substantial property owned by the Seller. (vii) The Seller has misrepr esented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
- 10. In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.
- 11. Service & Support: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service centre is not already there at the t ime of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be r eleased only after submission of documentary evidence of having Functional Service Centre. BIDDER/OEM must have Dedic ated/toll Free Telephone No. for Service Support and provide Escalation Matrix of Telephone Numbers for Service Support.
- 12. **Restrictions under Rule 144 (xi) of GFR 2017**: Any bidder from a country which shares a land border with India will be eligible to participate in this bid only if the bidder is registered with the Competent Authority in accordance with restrictions under Rule 144 (xi) of the General Financial Rules (GFRs) 2017 as amended from time to time. The bidders shall enclose th e following certificate along with the bid documents. *"I have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; I certify that this vendor/bidder is not from such a country or, if fr om such a country, has been registered with the Competent Authority. I hereby certify that this vendor/bidder fulfills all req uirements in this regard and is eligible to be considered for procurement from GeM. [Where applicable, evidence of valid re gistration by the Competent Authority shall be attached]."*
- 13. Liquidated Damages: If the supplier fails to deliver or install/commission any or all of the goods or fails to perform the se rvices within the time frame(s) incorporated in the Purchase Order/GeM Contract, the Buyer shall, without prejudice to oth er rights and remedies available to the Buyer under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, commissioning and/or se rvices until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reach ed, Buyer may consider termination of the contract.
- 14. If any delay by the supplier in maintaining its contractual obligations towards delivery of goods and performance of service s shall render the supplier liable to any or all of the following sanctions: (a) Imposition of liquidated damages, (b) Forfeiture of its Performance Security and (c) Termination of the Contract for default
- 15. Bidders must ensure that only the concerned document is uploaded in a particular field for document upload. Uploading th e same document in multiple fields should be avoided.
- 16. Bidder's offer is liable to be rejected if they do not upload any of the certificates/ documents sought in the Bid document, A TC and Corrigendum if any.
- 17. List of documents to be attached along with Technical/Financial Bid
 - a. Format A, B, C, D, E & F Along with Financial Bid (Financial document required)
 - b. Annexure I, II & IV Along with Technical Bid.
