4	Rate of Cost Per Reportable Test to be quoted. This will include all incidental expenses, cost of reagent, calibrators, controls, probes, washing solution, resins (if applicable) and GST. The cali brators, controls, etc will be used as per NABL stipulation. All breakdown maintenance, transpo rtation, loading and unloading, spare parts & AMC/CAMC, preventive maintenance kit, remedial maintenance service and calibration shall be the sole responsibility of the bidder at th eir own risk cost and expenses. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
