Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

## **Buyer Added Bid Specific Additional Terms and Conditions**

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). I service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidenc of having Functional Service Centre.
- Bidders can also submit the EMD with Account Payee Demand Draft in favour of Director, SCTIMST, payable at Trivandrum

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

- 4. Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name c the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date
- 5. **Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- 6. Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide Comprehensive Maintenance Service for next 4 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into a CMC agreement with the Successful Bidder / OEM after expiry of the Warranty period at above mentioned rate and the payment for the CMC charges would be made Biannually after rendering of the CMC Services of the relevant CMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the CMC contract when called upon by the buyer. CMC would include cost of

(Upload the undertaking). The original Performance Security of contract will be returned only after submissior and verification of AMC Performance Security for 3% of total CMC value valid up to CMC period plus 2 months (if there is no other claim).

- 7. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### About SCTIMST

Sree Chitra Tirunal Institute for Medical Sciences and Technology (SCTIMST) is an Institution of National Impor ance under the Department of Science and Technology, Govt. of India.

#### Introduction:

The Computer Division of the Institute maintains all in-house developed software applications for various se tions including the critical Hospital Information System (HIS). All applications of the Institute at present use Oracle as the RDBMS. The application is mission-critical as any downtime will directly affect the service to p ient care services and to the Institute management. The current version of the RDBMS is Oracle Database 1 c Enterprise edition with forms and reports. To ensure high availability and prevent any data loss, the Institute e has a disaster recovery site in a remote location and maintains a standby database using Oracle Data Gua d technology.

The Institute wishes to develop/upgrade the application and the database to the latest version supporting al modern features and data security. The Institute has to ensure that the present application is highl available, secure, and has high performance and would like to have the support for another 7 years.

#### 1. <u>Summary of Scope of Work</u>

- Supply, Installation, Configuration, Testing, Commissioning and Maintenance of highly available clust red Database infrastructure complying with the technical specifications mentioned below. Post-commis ioning support from the Bidder is required for the next seven years. (Three-year warranty and four year AMC).
- The Bidder should provide a robust database infrastructure solution for the Institute Information Syst m and other critical applications, enhancing the application to be highly secure, highly available, scalal e, and with high performance.
- The Bidder should provide two Database Installations in SCTIMST. One installation is in the Productio
   Site (Data Center Hospital Wing) with the proposed new hardware infrastructure, and another one is i
   the Disaster Recovery Site (PMSSY Block) with the existing hardware.
- The database on the production site has to be configured in a high availability active-active cluster r ode. The system should provide redundancy in both Hardware and Software. The Bidder should provide the latest version of the database hardware appliance to ensure the production site is highly available. xisting database appliance hardware (Oracle ODA X6-2HA) to be configured as the DR server and to pr vide a data replication from the production site to the DR site. The database environment should also b capable of running multiple application databases in one server so that SCTIMST has fewer database se vers to monitor and manage, thereby reducing the server management costs.
- Migration of whole data from the existing Oracle Database 12c to the new database system with min mum downtime as mandated by SCTIMST.
- · Warranty and Maintenance of the procured appliances and the associated hardware and software.
- · Training & Documentation.

#### 2. Detailed Scope of Work

#### Delivery, Installation, Configuration, Testing & Commissioning:

- i. All steps required to commission the new Database Server and Software System at SCTIMST's Data C nter to be carried out. They should include but not be limited to the following
  - a. The supply, installation, commissioning and configuration of Database Servers and Software Sy tems in high availability active-active cluster mode.
    - 1. Unboxing all hardware items including servers and storage enclosure.
    - 2. Racking and mounting of the hardware devices.
    - 3. Power on system.
    - 4. Creating the required number of virtual machines as per the deployment architecture for he database and applications.
    - 5. Installation of the required Operating system on the VMs / Templates.
  - b. VLAN Creation.
  - c. Upgrade to the latest operating system and database software image.
  - d. Network configuration for Virtual machines.
  - e. Installation of the latest database software version depending upon the environment.
  - f. Auto backup setup for virtual machines.
  - g. Create and test virtual machine failover.
  - h. Configuration of the database as highly available.
  - i. Setting up the replication of various databases from DC to DR and vice versa.
  - j. Integration of the existing SAN/NAS Storage (External) and provisioning of the same for the data base backup.
  - k. Development and deployment of the auto switchover to the DR. Automated switching option fo the DC & DR Setup.
- ii. Bidder to provide such packing of the products and insurance required to prevent its damage or deteric ation during transit to the location given by SCTIMST. The packing shall be sufficient to withstand rough andling during transit and exposure to extreme weather conditions during transit and open storage.
- iii. Bidder will have to supply the Products in 'Factory Sealed Boxes' with OEM seal.

iv. Delivery, installation and commissioning of the products shall be made by Bidder in accordance with the roduct approved / ordered and within the time schedule given in the GEM order.

v. The delivery shall be deemed complete when the Products/components/associated software/firmware ar received in good condition at the designated locations, mentioned in this RFP/GEM order.

vi. Prior to the installation, configuration, and Integration, the Bidder will need to study the existing setup a SCTIMST's Data Centre and to prepare a detailed implementation plan. On approval of the same by SCTII ST, installation and integration of database infrastructure implementation has to be carried out.

vii. The installation will be deemed to be completed when,

a. The product, including all the hardware, accessories/components, firmware/system so ware (latest versions), and other associated components have been supplied, installed, ir egrated and operationalized within SCTIMST's existing network and system as per the tec

nical specifications.

- b. All the features, as per the technical specifications, are demonstrated and implemented on SCTIMST's existing network system, to SCTIMST's satisfaction.
- c. Migration of the databases as identified by SCTIMST.

The Bidder, working with the OEM, has to resolve any issue faced during the installation and operationalization of the hardware.

- viii. The Bidder will supply all associated documentation relating to the Products/hardware, system soft are/firmware, etc. The Products shall be accepted (commissioned and operationalized) after the signi g of the acceptance test plan document jointly by the representative of SCTIMST and the engineer fr m the Bidder side.
- ix. For the additional hardware, system and other software/firmware required with the hardware orde ed for, the following shall apply:
  - a. Bidder shall supply standard software/firmware package published by third parties in o out of India in their original publisher-packed status only, and should have procured the s me either directly from the publishers or from the publisher's authorized representatives nly.
  - b. Bidder shall provide complete legal documentation of all sub systems, licensed operati g systems, licensed system software/firmware and licensed utility software and other lice sed software.
  - c. In case Bidder is providing software/firmware which is not its proprietary software then idder should have valid agreements with the software/firmware OEM for providing such so tware/firmware to SCTIMST, which includes support from the software/firmware OEM for t e proposed software for the entire period required by SCTIMST.
  - d. The ownership of the supplied hardware and software shall be that of SCTIMST from the date of put to use.
- x. Bidder to execute the detailed Proof of Concept (POC) of the proposed solution with the sample d ta and application environment provided by the institute. Before the POC execution; the bidder to con rm with SCTIMST the type of hardware planned, software/firmware required with the hardware, and d tails of the database version selected etc. so that the product/idea can be turned into a reality.

As part of the POC activity, the bidder has to test the proposed database and application server soluti n with the test data provided by the SCTIMST using applications developed in PHP, Laravel, Java FX v th RESTful services and Oracle Forms/Reports Applications.

Bidder has to mention in detail the methods / protocol, additional work to be carried out by the buyer ost data migration etc so that the existing application will work in the new environment. Cost of the h rdware/software required for the POC to be handled by the bidder. The results of the POC will be exan ned by the technical committee for further evaluation.

xi. Post commissioning, Bidder/OEM should support the managing of the device for 3 years as warr nty and the next four years as CAMC.

#### Warranty/Service Support:

- i. Bidder/OEM shall comprehensively support the Product and its associated hardware/compone ts including OS/firmware (preventive maintenance, critical hot fixes, service packs, and major upgra es) during the warranty period and AMC period.
- ii. During the Warranty and CAMC period, Bidder/OEM will have to undertake comprehensive sup ort of the entire Product (hardware, components, operating software, firmware, etc.) supplied by th m at no additional cost to SCTIMST.
- iii. During the Warranty period, Bidder/OEM shall ensure that services of professionally qualified p

rsonnel are available for providing comprehensive on-site maintenance of the Product and its compc ents as per SCTIMST's requirements.

- iv. Onsite comprehensive warranty for the product (hardware/ software) would include free replac ment of spares, parts, kits, and resolution of the operating system or database software problems, i any, in the product.
- v. Support (Warranty) would be on-site and comprehensive from the Bidder/OEM.
- vi. In the event of system breakdown or failures at any stage, the following shall be provided.
  - a. Diagnostics for identification of systems failures.
  - b. Protection of data/ Configuration.
  - c. Recovery/restart facility.
  - d. Backup of system software/ Configuration.
  - e. Service call registration, detailed service report etc.
  - f. Any other action deemed necessary to restore the system.
- vii. Bidder/OEM shall be available for on-call/on-site support during any maintenance activity or at t e time of switching over from DC to DR and vice-versa during mandatory DR Drills or as per requirer ent. No extra charge shall be paid by SCTIMST for such needs, if any, during the support period.
- viii. Bidder support staff should be well-trained to effectively handle queries raised by the authorized user(s) of SCTIMST. In the bid the bidder should provide the details of the technical staff authorized r the service by providing the qualification and count.
- ix. To updated the escalation matrix shall be made available to SCTIMST, each time the matrix is hanged.

#### Migration of the existing Oracle Enterprise Databases version 12c & Application integration

SCTIMST intends to migrate its enterprise database to the latest version database system. Apart from one ime implementation and commissioning services for the proposed hardware, the Bidder/OEM shall underta e database Migration Services and Support Services after Go-live.

- i. Post commissioning of the proposed database hardware infrastructure, Bidder, shall provide supp rt from the OEM for the enterprise applications and databases in case of any problem/issue found rela ed to post migration. The current application is developed on Oracle RDBMS.
- ii. Bidder shall develop a detailed project plan to complete the migration activities. The migration preect plan shall include the approach as well as the activities required for testing iterations and a test e vironment migration. For data migration; copying data to third part site/server is not permitted and th activity is to be carried with high data security with no data loss.
- iii. Bidder shall study and review the current applications and its infrastructure while designing the mic ation solution and developing the project plan. The migration activity shall be taken up post approval f the detailed project plan by SCTIMST.
- iv. Bidder shall carry out the test run with limited data. Post acceptance of the test run by SCTIMST, Bi der would initiate the final migration, which shall be subject to test and audit of the data by SCTIMST r an agency identified by SCTIMST to ensure accuracy of the data during the migration activity. Post a ceptance of the final migration, activity would be considered as completed, otherwise, bidder is suppr ed to repeat the exercise until SCTIMST accepts it.
- v. Bidder shall ensure there is comprehensive support from the OEM during the migration exercise so that the issues are addressed as per standards specified in the SLA.

vi. Bidder shall ensure proper documentation and lessons learnt are made available with SCTIMST duri g and after the migration project.

#### Training & Documentation:

- i. Bidder shall submit a training plan to ensure that SCTIMST and its designated IT staff are tr ined properly to continue with the maintenance and monitoring of the Product.
- ii. Bidder shall provide, at their cost, all training at a location and the mode agreed to by SCTI ST.
- iii. Bidder shall develop and share the training material on all aspects of the Product and its ass ciated tools (hardware, software, firmware etc.) that will be utilized.
- iv. Bidder shall provide all operational system documentation, system administrator operations manual, system maintenance documentation, and final system test plans, test scripts & test case

#### **General Services:**

- i. Bidder/OEM shall ensure that key personnel with relevant skillsets are available at designated locations for installation and commissioning of the product.
- ii. Bidder shall designate a skilled Project Manager who may be asked to periodically update a d report to SCTIMST on the project. The updates shall have to be provided in written form and du ng the status review meetings.
- iii. Bidder shall ensure that the quality of methodologies for delivering the Products/Services ad ere to quality standards/timelines stipulated thereof.
- iv. Bidder shall provide and implement patches/ upgrades/ updates for Products (software/ firm are/ OS) as and when released by OEM free of cost. Bidder should bring to the notice of SCTIMST Il releases/ version changes.
- v. Bidder shall follow SCTIMST's Change Management process and obtain written permission om SCTIMST before applying any of the patches/ upgrades/ updates. Bidder has to support older ersions of the OS/ Firmware/ Middleware etc in case SCTIMST chooses not to upgrade to the latest version.
- vi. Bidder shall provide maintenance support for the Product including embedded software/ OS middleware etc. over the entire period of the Contract.
- vii. Bidder shall provide legally valid firmware/software. Detailed information on license count an type of license should be provided to SCTIMST.
- viii. Bidder/OEM shall keep SCTIMST explicitly informed about the end of sale, and end of support ates, on related Products including embedded software/ OS/ middleware etc. as and when the sar e is released by OEM.
- ix. The device should provide an audit trail and logs for every transaction /activity performed in the system and shall generate audit reports / logs as and when needed. This is an end-to-end proct and all the items required for making the device operational should be considered by the bidde , even if the same is not explicitly mentioned in this Bid document.
- x. Bidder should ensure that the installed Database Management System is up and running w h the latest available release of DBMS software & patches at any time during the contract period nd during the exit of the bidder at the end of the warranty & AMC completion period.

#### 3. <u>General Terms And Conditions</u>

- Equipment furnished shall be complete in every respect with all mountings, fittings, fixtures and tandard accessories normally provided with such equipment's and / or needed for erection, comple on and safe operation of the equipment's as required by applicable codes though they may not hav been specifically detailed in the tender document, unless included in the list of exclusions. All simila standard components / parts of similar standard equipment's provided, shall be inter-changeable v th one another.
- 2. The bidder shall be responsible for providing all materials, equipment's, and services, specified o otherwise, which are required to fulfil the intent of ensuring operability, maintainability, and reliabil y of the complete equipment covered under this specification within quoted price. This work shall b in compliance with all applicable standards, statutory regulations and safety requirements in force f the date of award of this contract.
- 3. The bidder shall be responsible for deputing qualified and certified personnel for installation, tes ng, commissioning and other services under this scope of work as per this specification. All require tools and tackles for completing the scope of work as per the specification is also the responsibility f the bidder.
- 4. The bidder should follow guidelines for the implementation in the proposal.
- 5. The bidder should conduct site survey if required to identify the site in coordination with SCTIMS1
- 6. UPS output power for the rack will be provided by SCTIMST.
- 7. The bidder should ensure, during installation of LAN, day-to-day functioning of official work an existing network setup / connectivity / internet connectivity are not disrupted.
- 8. The specification mentioned in the Bid is minimum. Bidder can quote products having higher con gurations.
- 9. SCTIMST reserves the right for quantity variation due to increase / decrease in requirements.
- 10. Product make, model number and part number of each module/components to be clearly mention d in the bid.
- 11. Free Updates and Upgrades for Software/Firmware during warranty and CMC period to be provided
- 12. The quoted items should be the latest product in the market and launched within three years from the date of publishing this Bid.
- 13. The bidder shall go through the entire document and must comply with all the terms and conditior . A Compliance statement in the form of "Complied", "Partially Complied "or "Not Complied" shall e given against each item and specification of the TENDER documents (Technical Specifications). The e compliance statements should be supported by authentic documentation. Any variation from "fu y-complied" shall be mentioned as "partially complied" or "Not Complied" and the variation shall be mentioned clearly in a separate "Remarks". Please note that any deviation from the laid down requirements/specifications shall be duly signed and stamped by the Bidder. Failing to comply with this equirement may result in the bid being rejected. Submit these documents along with the Technica

Bid.

- 14. Single bid will only be selected for the entire for having a single point of contact for support relate issues.
- 15. All Components offered in the Bill of Material should be covered under OEM support, enabling pro ram so that to get back-end support / benefits from Principles / OEM in terms of Free Support / Mair enance, if any, Access to 24 x 7 x 365 online support from Technical Assistance Centre of OEM for r solution of problems with the help of their technical team on-site/off-site, advance defective part re acement during warranty period within a period of two working days and OEM Login Access. The un ertaking from the OEM for the same should be enclosed with the technical bid.
- 16. The installation should be supported with spares for a minimum period of 7 years after successful nstallation and commissioning. "All the spares and consumables required for the equipment should be made available through GeM throughout the agreed supporting period". (A line of confirmation hould be submitted along with the bid document.)
- 17. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any r sponsibility in this regards. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
- 18. Compliance Sheet and Brochure of the product(s) offered in the bid, are to be uploaded along with the bid documents. In case of any unexplained mismatch of technical parameters, the bid is liable f r rejection.
- 19. Scope of Supply (Bid price to include all cost components): Supply Installation Testing Commissior ng of Goods and Training of operators and providing Statutory Clearances required (if any) Installat on, Commissioning, Testing, Configuration, Training (if any - whichever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller at consign e location free of cost. The payment will be released only thereafter.
- 20. The bidder shall not assign the Contract in whole or part without obtaining the prior written conser of buyer.
- 21. Participating bidders should submit OEM Authorization Certificate along with the bid documents as per the format given in Buyer uploaded ATC document (FORMAT F).
- 22. Bidder/OEM must have a Functional Service Centre in the State of Consignee's Location in case of arry-in warranty. (Not applicable in case of goods having on-site warranty). If service centre is not a eady there at the time of bidding, successful bidder / OEM shall have to establish one within 30 day of award of contract. Payment shall be released only after submission of documentary evidence of aving Functional Service Centre. Bidder/OEM must have Dedicated/toll Free Telephone No. for Service e Support and provide Escalation Matrix of Telephone Numbers for Service Support.
- 23. Warranty period of the supplied products shall be 3 Years from the date of final acceptance of goo s or after completion of installation, commissioning & testing of goods (if included in the scope of s pply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at

he time of delivery of Goods. The seller should guarantee the rectification of goods in case of any t eak down during the guarantee period. Seller should have well established Installation, Commission ng, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales : ervice. Details of Service Centres near consignee destinations are to be uploaded along with the bic

- 24. The bidder should submit a declaration confirming that the Product Cost / Total Cost does not include warranty charges other than OEM Warranty. If any charges claimed by the bidder towards **three** years warranty which is included in the Product Cost / Total Cost should be indicated in the declaration form. Aforesaid declaration in the FORMAT G should be submitted along with the technical bid. T e splitup of warranty cost (year wise) shall be provided by the bidder separately in the financial doc ment sought for FORMAT D.
- 25. Successful bidder will have to ensure that adequate numbers of dedicated technical service perso als/engineers are designated/deployed for attending to the Service Request in a time bound manne and for ensuring Timely Servicing/rectification of defects during warranty period, as per Servic level agreement indicated in the relevant clause of the bid. After having been notified of the defect service requirement during warranty period, Seller has to complete the required Service/Rectificati n within 3 days' time limit. If the Seller fails to complete service/rectification with defined time limit following penalty clause will be applicable.

#### 26. Penalty clause:

1. Delay in Delivery:

If the supplier fails to deliver or install/commission any or all of the goods or fails to perform the services with n the time frame(s) incorporated in the Purchase Order, the Purchaser shall, without prejudice to other rights nd remedies available to the Purchaser under the contract, deduct from the contract price, as liquidated dam ges, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, cor missioning and/or services until actual delivery or performance subject to a maximum of 10% of the contrac price. . SCTIMST reserve the right to cancel the order in case the delay is more than 10 weeks. If any delay b the supplier in maintaining its contractual obligations towards delivery of goods and performance of services hall render the supplier liable to any or all of the following sanctions:

- a. Imposition of liquidated damages,
- b. Forfeiture of its Performance Security and
- c. Termination of the Contract for default
- 2. Performance (during Warranty period)

Supplier should ensure uninterrupted service delivery of the equipment or product during the warrar y period. In this regard following conditions also may be noted:

- I. In case of failure of equipment or its components, breakdown call has to be attended w hin 48 hours of intimation.
- II. The defect should be rectified within three days after the call is attended, failing which r placement or standby equipment should be provided for uninterrupted services.
- III. In case of non-adherence to clause (a) or (b) above, downtime penalty will be realised a um equivalent either the repairing charges met by the Institute to set right the equipment or .5 percent per day of cost of the equipment, whichever is higher, from the date of report of br akdown by way of deductions from SD/Performance Bank Guarantee.
- IV. The time spent on the repair work will be added to the warranty period of the equipment
- 3. Performance (during CMC/AMC period):

- a) Uptime means 100 % of total days in a year, including Sundays and Institute Holidays
- b) Down time means any shortage in achieving the uptime of 100 %.
- c) Down time penalty will be levied at the rates shown below;
  - The Equipment for which EX-works/FOB/CIF value is up to Rs. 10 Lakhs, penalty is 1.5% pe day of such value of the equipment.
  - The Equipment for which Ex-Works/ FOB/ CIF value is above Rs.10 Lakhs but up to Rs.50 l khs penalty at 3 % per day of the cost of the equipment subject to a minimum of Rs.5,000/ per day.
  - The Equipment for which Ex- Works / FOB/ CIF value exceeds Rs.50 Lakhs, penalty is at 4 ' per day of the cost of the equipment subject to a minimum of Rs.10,000/- per day and max mum of Rs.50,000/- (Rupees Fifty Thousand Only) per day for the first week which will dout e every subsequent week.
  - The Penalty will be leviable for each (a single) equipment.
  - Even if the total days of downtime in a year is below 1 %, if the equipment is down for mo than 2 working days continuously, excluding reporting and repairing days, on any occasio , a penalty at the above rate will be levied for such down time exceeding 2 days. For this pu pose repairing day is a single day on which the machine is reported as repaired and working means fully working.
- 27. List of Essential Spares & Consumables: If the equipment contains any essential spares and cons mables, the price should be frozen for minimum 4 years after warranty period. The price of the spa es and consumables should be submitted separately by the bidder in the Financial Document soug t for. The format is available in the Buyer uploaded ATC document.
- 28. If the item involves software, the successful bidder should obtain software license in the name of Director, SCTIMST' and the paper license / email license to be transferred to the name of Institute.
- 29. Malicious Code Certificate: The seller should upload following certificate in the bid: -
