1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. - 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - All Provisions of Drugs and Cosmetics Act, 1940 and Rules (including Medical Device Rule 2017)
 made there under as amended till date will always be applicable. This will include all notifications
 issued by Central Drugs Standard Control Organization (CDSCO), Ministry of Health & Family Welfare
 (MoHFW) and Department of Pharmaceuticals (DOP), Ministry of Chemicals & Fertilizers time to time
 in this regard.
 - 2. The sellers are registered on GeM based on self-declaration of valid Drug License, product certification, test reports etc. However, buyers must check and validate the details at their end for all applicable licenses and certifications e.g., validity and authenticity/genuineness of drug license, product certification, manufacturer certification/licenses, test reports etc.
 - 3. In case of authorized resellers/distributors, it will be the legal & regulatory liability of the manufacturer to ensure that their resellers/distributors are operating in compliance with all relevant laws and regulations and are properly licensed to sell the manufacturer's products, including verifying the validity and authenticity of drug license held by them.
 - 4. The price offered by the seller/bidder shall not, in any case exceed the DPCO/NPPA controlled price or price fixed by State Government, if any. The seller must reduce the prices if there is any reduction in DPCO/NPPA ceiling price or price fixed by State Government, if any.
 - 5. Any other Terms and Conditions which is not included or at variance with the conditions specified in STC/GTC, may be added by the buyer through Additional Terms and Conditions (ATC) in the bid to ensure items are procured from authentic/validated source with appropriate and applicable quality. The above terms and conditions are in reverse order of precedence i.e. ATC shall supersede specific STC which shall supersede General Terms and Conditions (GTC), whenever there are any conflicting provisions.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

7. Warranty

Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide Comprehensive Maintenance Service for next 5 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into a CMC agreement with the Successful Bidder / OEM after expiry of the Warranty period at above mentioned rate and the payment for the CMC charges would be made Biannually after rendering of the CMC Services of the relevant CMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the CMC contract when called upon by the buyer. CMC would include cost of

8. Certificates

A. Bidders are advised to quote prices separately as per technical specification and additional specific ations mentioned in the bid. However detailed breakup of quoted prices should be provided in Price Format - A and uploaded in the prescribed place (Financial Document Required) on online GeM porta I. The prices quoted in the prescribed field on GeM portal will be considered for ranking purpose. - B. The Bidders are advised to quote price of Spare parts, Consumables in the attached Format B and C accordingly and uploaded the same in the prescribed place (Financial Document Required) on online G eM portal. The equipment should be supported with spares for a minimum period of 10 years after su ccessful installation and commissioning." All the spares and consumables required for the equipment should be made available through GeM throughout the agreed supporting period".
- C. The warranty for the equipment is for three years and CAMC is for seven years. The three years warr anty sought for is **OEM free warranty** without any additional cost towards extended warranty to fulfil the tender condition. The charges, if any, claimed by the bidder towards warranty in this regard and included in the product cost in Price Format -A should be mentioned in the price format D also. This warranty charges shall not be considered for calculating actual CAMC value to be payable after warrant y period. - D. As per the Institutes general policy, the maximum CAMC charges after warranty period will be 5% of the cost of the equipment. However, the bidders can quote CAMC charges in the range of 3 to 10 % of the cost of equipment, depending on the nature of equipment to be maintained. The CAMC charges s hall be quoted in percentage rate in GeM bid and escalation in CAMC charges shall be allowed at maxi mum 5% of the CAMC charges after every three years of CAMC. This CAMC charges at Net Present Val ue shall be taken into account for arriving the lowest responsive bidder. F. Penalty clause:

1. Delay in Delivery:

If the supplier fails to deliver or install/commission any or all of the goods or fails to perform the service s within the time frame(s) incorporated in the Purchase Order, the Purchaser shall, without prejudice to other rights and remedies available to the Purchaser under the contract, deduct from the contract price , as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, commissioning and/or services until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reached Purchaser may consider terminat ion of the contract.

If any delay by the supplier in maintaining its contractual obligations towards delivery of goods and per formance of services shall render the supplier liable to any or all of the following sanctions:

- a. Imposition of liquidated damages,
- b. Forfeiture of its Performance Security and
- c. Termination of the Contract for default

2. Performance (during Warranty period)

Supplier should ensure uninterrupted service delivery of the equipment or product during the warr anty period. In this regard following conditions also may be noted:

- I. In case of failure of equipment or its components, breakdown call has to be attended wit hin 48 hours of intimation.
- II. The defect should be rectified within two days after the call is attended, failing which re placement or standby equipment should be provided for uninterrupted services.
- III. In case of non-adherence to clause (a) or (b) above, downtime penalty will be realised a sum equivalent either the repairing charges met by the Institute to set right the equipmen t or 0.5 percent per day of cost of the equipment, whichever is hig her, from the date of re port of breakdown by way of deductions from SD/Performance Bank Guarantee.
- IV. The time spent on the repair work will be added to the warranty period of the equipment

3. Performance (during CMC/AMC period):

- 3. The sterilization chamber should be made up of suitable alloy which is resist ant to corrosion and ETO gas.
- 4. The chamber should be insulated against heat emission.

- 5. The construction of the chamber, door and all contact parts should be rust proof. It should be made up of stainless steel of 316 grades or rust proof anodized aluminum.
- 6. The inner surface should be smoothly finished to minimize gas deposits.
- 7. The sterilizer door should have a quick release locking arrangement. The door locking should be automatic. There should not be any handle at door to avoid t edious locking process. There should be provision for door push to lock the door and touch screen to unlock the door.
- 8. There should be safety interlocking arrangement for the door so that the steri lization process does not start unless the door is properly locked in position and during the programme run, it shouldnot open unless the residual gas has been completely eliminated from the chamber.
- 9. The sterilizer should have suitable mechanism to separate and evacuate residual gas from the chamber.
- 10. The sterilizer should have following cycle programmes a. Sterilization cycle f or heat sensitive objects that ensure temperature from 370C-550C with subseq uent aeration for protection of the operating personnel. b. Aeration cycle / programmed to extract residual gas out of the sterilized objects after each sterilization cycle. c. Automatic chamber evacuation cycle with subsequent venting before releasing the doorlock for opening, thereby prohibiting exposure of the operating personnel by gas dissolving from the chamber walls during shut downperiod.
- 11. The sterilizer should have a minimum chamber capacity of 200 litres or above.
- 12. Should be suitable for 2 carriage basket for sterilization load.
- 13. The ETO cartridge puncturing mechanism must be automatic and must not require any manual operation during sterilization process.
- 14. Vacuum should be created only through ventury system using the existing c entral air system available in the hospital at 4 bar. If the quoted system require s higher pressure, a separate compressor should be provided along with the system.
- 15. In case if the ETO cartridge does not puncture inside the ETO machine, then there should be an option for alarm and it should be displayed as "cartridge puncture failure".
- 16. One complete sterilization cycle should contain all the phases and it should be finished within 8-10 hours. All time-based parameters must be mentioned in printing.
- 17. Documentation Thermal Printer / Dot-Matrix Printer Should Print Date, Batc h/ Load Number, Program Type Elected and Program Parameters Which Include s One Point Pressure and One Point Temperature Print Out.
- 18. The temperature, pressure and status (along with all alarms) of the cycle m ust display on HMI screen during sterilization process. It should have minimum of 6"colour display touch screen for operation.
- 19. During sterilization cycle, the chamber pressure must maintain negative pressure. Negative Pressure Cycle (100% ETO Cartridge) indicative Cycle descripti

- on: a) Vacuuming of chamber to set value b) Leak hold period c) Cartridge punc turing / gas purging depending on the cycle selected. d) Sterilization hold period for set time. e) Exhaust and aeration for number of aeration pulses set.
- 20. There should be reminder for ETO cartridge and fill water (RO water) before the start of cycle.
- 21. There must be an alarm in case of vacuum/air break could not be achieved in desired time and also for high temperature
- 22. The touch screen should have features like audit trail, alarm logging and multiple passwords.
- 23. The OEM of the quoted machine shall service personnel of the OEM deputed in Kerala or Tamil Nadu. To ensure adequate installations and service presence, there shall be at least 10 installations for the OEM (at least 100 litre capacity and above) within 500 kms from Thiruvananthapuram
- 24. The quoted model shall have the licence issued by Central Drugs Standard C ontrol Organization(CDSCO) under Directorate General of Health Services, Minis try of Health & Family Welfare, Government of India as per the Medical Devices Regulation act (MDR).
- 25. Catalytic converter or equivalent technology for safe disposal of E.O. Gas / Gas disposal management -to be as per local pollution control norms if any
- 26. Technical selection shall include the demonstration of the product at SCTIMS T or at any of the nearby installation location on request. Performance certificat e from the competent authority of existing installation of the model quoted in o peration for at least 3 years shall be submitted along with the bid.
- 27. The vendor should provide 100 numbers of ETO cartridges and Packaging Material with Chemical Indicator of All Sizes: 10 rolls along with the sterilizer.
- 28. The vendor should disclose the list of consumables required for each cycle of sterilization process.
- 29. The vendor has to undertake the supply, installation, testing and commissioning of the ETO sterilizer.
- 30. The necessary civil, electrical, copper exhaust piping (approx. 20 meter) and plumbing works if required for the installation of ETO machine has to be done by the vendor. The vendor may inspect the installation site prior to quoting the price.
- 31. All regulatory requirements for installing ETO sterilizers should be incorpora ted within the site; including the safe disposal of exhaust gas from the sterilizer as per existing regulatory norms.
- 32. All regulatory requirements (including the safe disposal of exhausted gas from the machine) for the safe installation of ETO sterilizer should be incorporated within the site.
- 33. There should be an appropriate pollution control device (ETO Abator) for sa fe disposal of ethylene oxide like catalytic converter or equivalent technology / gas disposal management to be as per local pollution control norms, if any . PRI CE OF THE ABATOR SHOULD BE QUOTED SEPARATELY IN THE PRICE BID.

- 34. ETO leak detector with audiovisual alarms should be provided.
- 35. Standards and Safety
- 35.1 Shall meet IEC-60601-1-2:2001 General Requirements of Safety for Electro magnetic Compatibility EMC directive.
- 35.2 The ETO Sterilizer manufacturer should provide certificates for compliance with ISO 9001: 2015. ISO 13485:2016 ISO 45001:2018.
- 36. All civil and electrical works required for the installation work including site preparatory work if any shall be included in the scope of the bidder as turnkey work.
