- 2. SCTIMST reserves the right to accept/reject any or all the tenders in part/full without assigning any reas on thereof.
- 3. Any change/corrigendum/extension of opening date in respect of this tender shall be issued through we bsites only and no press notification will be issued in this regard. Bidders are therefore requested to regula rly visit our website for updates.
- 4. Director, SCTIMST reserves the right to award the contract to a single party or more than one party.
- 5. On acceptance of the contract, the agency should submit a signed service agreement in Rs.200/- stamp paper containing the terms and conditions of the contract, as specified by the institute.

INSTRUCTIONS TO BIDDERS

- 1. The service provider should have an office in Thiruvananthapuram district for smooth facilitation of servi ces. Documentary evidence to prove the registered office at Thiruvananthapuram should be attached alon q with bid.
- 2. The bidder should deposit an amount of Rs.10,000/-(Rupees ten thousand only) towards EMD in favour of The Director, SCTIMST, Thiruvananthapuram.

3. Payment Terms: No advance payment in any case would be paid. Payment will be made on monthly ba sis through e-payment as per rule on receipt of GST bill (mentioning the GST number of both the agency a nd the Institute) along with duty slips certified by the Officer-in-charge/ Transport Supervisor / concerned officials.

The firms are required to furnish/upload copies of the following documents:

ANNEXURE-I

GENERAL TERMS AND CONDITIONS

- 1. The contractor may provide the required number of vehicles as and when required by SCTIMST on any d ays including holidays (24x7 services).
- 2. The scope of contract includes providing transport services in hospital wing (near Medical College) as well as Biomedical Technology Wing (Poojappura). **Quoted rates shall be applicable to the services p rovided in both locations of the institute.**
- 3. The vehicles should be in good condition and well maintained with all necessary statutory documents. T he vehicles must possess all relevant documents like Registration, valid insurances papers, fitness certific ate, pollution certificate, permits and other related papers as issued by the RTO.
- 4. All the Vehicles should be less than 5 years old. The vehicle to be provided to us should be covered und er Comprehensive Insurance Policy. Vehicle insurance must cover passengers also. Accidental compensat ion, if any, should be paid by the contractor or the Insurance Company and the Institute will not be respon sible for any sort of compensation. The agency should own a minimum of one vehicle in each category (Ha tchback, sedan, SUV) with valid permits. The documents related to ownership should be submitted with the technical bid.
- 5. During the contract period, if the vehicle is seized or detained or requisitioned by Police/Motor Vehicle A uthority or any other authorised for whatsoever reasons that will be at the service provider's risk and shall arrange alternate vehicle with no extra cost. The vehicles should confirm to motor vehicle inspection stan dards and should have registration as commercial vehicle with yellow number plate. All the vehicles should possess valid documents.
- 6. The drivers on duty should be in uniform (white shirt) as stipulated by motor vehicle rules. The drivers of the vehicle provided for hiring will be the employee of the contractor and there will be no employee-employer relationship between the Institute and the drivers during the period of hiring vehicle by the Institute. The service provider shall provide uniforms, badges and photos identity cards at his cost to the driver's in compliance with the Motor Transport Workers Act.
- 7. Initially the terms of the contract will be for a period of one year from the date of issue of letter for awar ding the contract. However, depending upon the need/and urgency, the Institute may extend this period fo r another year as per requirement on the same terms and condition without any cost escalation.
- 8.The SCTIMST shall recover all source, Income Tax, TDS on GST and other taxes as per statutory orders of Govt.on the gross bill value, payable per month to the contractor at the rate prescribed and it the same to the concerned authorities.
- 9. It can be terminated by either of the parties at any time giving a notice period of two months.
- 10. Trip sheets for the services rendered shall be submitted along with the invoice. Trip sheets should include the signature and remarks of the travelling official. Incomplete documentation/ without trip sheet, bills

will not be settled.

- 11. Rates quoted should show the charges as well as the applicable GST rate separately. GST will be paid as applicable from time to time. The rates should be inclusive of driver & vehicle maintenance charges. An amount of Rs.300 shall be paid as trip allowance per driver per occasion for overnight stay in outstation tri ps. No other additional payment shall be made by SCTIMST under any heading beyond the rates quoted in the tender. Conditional tenders will be rejected. In case of no quotes against a particular item in the tende r(s), this should be clearly mentioned along with reasons. The institute shall reimburse toll charges, parkin g charges and Inter-state permit charges paid during the assigned trips, on production of documents. The rates quoted in the commercial bid should be valid for a minimum of 12 months from the date of award of contract.
- 12. The kilometres shall be calculated on the basis of Zero-based mileage starting from the office and duty time shall be counted from the reporting point to the relieving point. Actual mileage only should be charge
- 13. Rate for Extra hour/kilometres should be quoted in detail for each category of vehicle.
- 14. It shall be the responsibility of the agency to meet the transportation, food, medical and any other exp enses in respect of the drivers of the hired vehicles.
- 15. The penalties relating to the following are to be borne by the contractor. i) Usage of mobile phone and alcohol while driving. ii) Accidental offence. Iii) Parking violation. In case of unsatisfactory service, the agen cy shall replace the vehicle, driver or both as per the request of the institute.
- 16. In case of any breakdown of the vehicle on duty ,the agency shall make arrangement for providing ano ther vehicle immediately within two hours.
- 17. Selection of the firms will be made based on the lowest quoted rates.
- 18. If the vehicle is not provided within the time specified for more than 3 times, the contract will be termi nated without any prior notice.
- 19. Drivers should have valid driving license with experience to drive the vehicle. The drivers should always remain with the vehicle during the entire period of duty. In case of any need, they should seek permission from the concerned officers.
- 20. The service provider will comply with labour laws in force and all liabilities in this connection will be his responsibility.
- 21. In case of non-satisfactory services during the period of contract, the institute shall be at liberty to impose a penalty amount of Rs.500/-(Five hundred only) at a time, with the approval of the Director, SCTIMST.
- 22. The vehicles to be provided should be not more than 5 years old and approved for running on commer cial basis only. The private vehicles will not be engaged for the purpose. The vehicles should be in excellent conditions both technically and in appearance particularly as to the upholstery and body painting etc.
- 23. <u>Rate for Extra hour/kilometres should be quoted in detail for each category of vehicle</u> Charges for extr a kilometers and extra hours must be submitted in the sample format attached as Annexure –2.
- 24. The rates quoted should give details such as kms/day, night halt charges (conditions is any including d river allowance),outstation duty charges in the sample format as in Annexure -2.
- 25. No change in the quoted rates shall be permissible, even if there is a variation in the fuel prices . The q uoted rates shall be valid for a period of one year from the date of onset of contract.
- 26. The service charges shall be paid on submission of bills of a particular month. The monthly bills must be submitted in the first week of the subsequent month and the payment will be made within 30 days of submission of invoice.
- 27. The agency should remit GST collected from the services to the concerned authorities and should sub mit proof on demand. In case of failure to submit the correct proof, the amount shall be recovered from su

bsequent bills/security deposit.

- 28. Liquidated damage clause: If the required vehicle is not provided and the substitute is not arranged in time, the Institute will arrange for the same and the additional expenses sustained by the Institute on this account will have to be borne by the agency. This will be recovered from the payables to the agency.
- 29. Recovery Clause: All losses liquidated or otherwise due to the violation of terms and conditions of the work order or defective documentation will be to the agency's account.
- 30. Determination of lowest bid: Negotiation will be carried out with the lowest tenderer; intimation of the same will be given separately.

Negotiations: Online/offline negotiations will be carried out if required with the L1 bidder as decided by the committee. Necessary intimations of time and date of negotiations will be given to the respective L1 bidde r after opening of the financial bids.
