If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 7 years residual market life i.e. the offered product shall not be declared end-oflife by the OEM before this period.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. Bidders are advised to quote prices as per technical specification and additional specification.

B. Bidders should submit the Manufacturer's Authorization in attached format- A (Buyer uploaded ATC Doc ument)

C. Liquidated Damages:

If the supplier fails to deliver or install/commission any or all the goods or fails to perform the servi ces within the time frame(s) incorporated in the Purchase Order, the Purchaser shall, without prejudice to other rights and remedies available to the Purchaser under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of good s, installation, commissioning and/or services until actual delivery or performance subject to a maximum o f 10 % of the contract price. Once the maximum is reached Purchaser may consider termination of the contract.

If any delay by the supplier is maintained its contractual obligations towards delivery of goods and performance of services shall render the supplier liable to any or all of the following sanctions:

- a. Imposition of liquidated damages,
- b. Forfeiture of its Performance Security and
- c. Termination of the contract for default

D. SCTIMST reserves the right to ask for a free demonstration of the quoted equipment/ items after giving r easonable time to the bidder at a pre-determined place acceptable to the purchaser or at a site (in case of non-portable and heavy equipment) for evaluating the technical compatibility as per the bidding document specifications, professionalism and quality of work of the bidder for technically qualifying for opening the P rice Bid. SCTIMST reserves the right to accept/ reject the bid based on the product/ site evaluation as state d above.

Detailed Specifications

SYSTEM PARAMETERS:

A. THE LATEST SYSTEM/MAKE/MODEL/VERSION/EDITION OF PATIENT CONTROLLED ANALGESIA (PCA) PUMP , LAUNCHED IN INDIA NOT MORE THAN 4 YEARS BEFORE THE DATE OF DELIVERY TO THE USERS, SHOULD BE SUPPLIED.

B) THE BIDDER SHOULD PROVIDE DATA IN A TABULAR FORMAT STATING FOLLOWING DETAILS REGARDING THE BIDDING ITEMS: PCA PUMP QUOTED: OEM; SYSTEM/MAKE/MODEL/VERSION/EDITION; YEA R OF FIRST SUPPLY IN INDIA

C) BIDDER SHOULD NOT INCLUDE PRICE BID IN THE TECHNICAL BID.

D) THE BIDDER SHOULD PROVIDE TECHNICAL DETAILS OF THE PCA PUMP, PREFERABLY AS A PRODUCT BR OCHURE.

STRUCTURAL PARAMETERS:

• THE PCA PUMP SHOULD BE AMBULATORY AND MOUNTABLE ON TABLE TOP AND ONTO AN IV POLE OR PA TIENT BED RAIL.

• IT SHOULD OPERATE ON EXTERNAL AC ELECTRICAL SUPPLYOR ONLITHIUM-ION OR AA ALKALINE BATTER Y. IT SHOULD HAVE BATTERY BACKUP OF AT LEAST 5 HOURS AT A RATE OF 5 ML/ HOUR WHEN FULLY CHARGED. PERFORMANCE PARAMETERS:

• IT SHOULD DETECT SYRINGES RANGING FROM 5 ML TO 60 ML OF COMMONLY USED BRANDS. IT SHOULD DETECT DIFFERENT PARTS OF SYRINGES SUCH AS PLUNGER AND FLANGE.

• IT SHOULD WORK OVER A WIDE RANGE OF PRESSURES SENSED BY THE PCA PUMP.

RECURRENT DISPOSABLES:

• IT SHOULD WORK WITH DISPOSABLE SYRINGES, 3-WAY STOPCOCKS AND EXTENSION TUBING OF ANY BR AND. NO VENDOR-SPECIFIC RECURRENT DISPOSABLES SHOULD BE NEEDED FOR FUNCTIONING OF THE PC A PUMP.

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
