If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior

written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

5. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

6. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

7. Buyer Added Bid Specific ATC

1. Only Manufacturers, their accredited agents, or authorized distributors are eligible to participa te in the tender. Additionally, they must maintain a functional office within Kerala state. Supporti ng documentary evidence of the functional office should be submitted alongside the quotation. *Offers lacking this documentation will be summarily rejected without further commu nication.*

2. The bidder is required to provide valid documentation to establish their status as a Manufact urer, accredited agent, or authorized distributor, which must be submitted alongside the technic al bid. The Manufacturer's name and the country of origin of the materials offered must be expli citly specified in the Manufacturer's Authorization Form. Additionally, the Manufacturer's Authori zation Form must remain valid for a minimum period of one year from the date of issuance. <u>For</u> <u>mat for MFA is enclosed in Buyer Added Bid Specific ATC (Format A)</u>

3. If an agent submits bid on behalf of the Principal/OEM, the same agent shall not submit a bid o n behalf of another Principal/OEM. In a bid, either the Indian Agent on behalf of the Principal/OEM or Principal/OEM itself can bid, but both cannot bid simultaneously in this tender. One Principal/OEM cannot authorize multiple agents simultaneously for the requirement as per this t ender. 4. All Provisions of Drugs and Cosmetics Act, 1940 and Rules (including Medical Device Rule 201 7) made there under as amended till date will always be applicable. This will include all notificati ons issued by Central Drugs Standard Control Organization (CDSCO), Ministry of Health & Family Welfare (MoHFW) and Department of Pharmaceuticals (DOP). In case the firm quotes imported b rands on behalf of their foreign principals / manufacturers which comes under the provisions of Drugs & Cosmetics Act & Rules, CDSCO certificate/license issued by CDSCO must be attached. 5. The price offered by the seller/bidder shall not, in any case exceed the DPCO/NPPA controlled price or price fixed by State Government, if any. The seller must reduce the prices if there is any reduction in DPCO/NPPA ceiling price or price fixed by State Government, if any.

6. The items supplied under this contract are essential for delivering super-specialty treatments. The use of substandard products could compromise both patient safety and the Institute's missio n. Therefore, the Institute reserves the right to request product samples at any stage of the tend er or contract period. Decisions regarding the selection or rejection of items will be made by the authority, based on the sample evaluation report prepared by the user department. 7. The estimated requirements mentioned in the tender are speculative and subject to significan t variation based on patient profiles. It is not feasible for the institute to determine exact quantiti es during the contract period, as specific items and sizes can only be identified during medical or surgical procedures, depending on the patient's clinical needs and treatment choices. According ly, the institute does not commit to the usage of items at any stage of the contract period.

8. Although the contract specifies a delivery timeline of 1 to 365 days, the successful bidder is o bligated to manage and adjust supply in accordance with the Institute's requirements. Items sup plied without prior consent from the department will be rejected outright, and payment for such items will not be processed under any circumstances. <u>Accordingly, a declaration confirming</u> this commitment must be uploaded with the technical bid. Failure to provide the decl aration will result in the offer being rejected without further communication.

9. The contract shall remain in effect for the purpose of delivering all items ordered during its ter m until every delivery is completed. The Institute reserves the right to request staggered supply during the contract period. The successful bidder must maintain an adequate buffer stock of the contracted items at their office in Kerala State to ensure that procedures are not disrupted due t o item shortages. Additionally, upon receiving a notification via email or phone from the user de partment, the successful bidder shall deliver the items within 24 hours.

10. The successful bidder, in consultation with the concerned department, may deposit items in advance at SCTIMST at their own risk and expense. The Institute will not bear any responsibility for these items or their usage during the contract period. Payment will be processed and release d only after the items have been administered to patients, with confirmation of use provided by the department. Consequently, the supplier may generate an invoice following the usage of the i tems, after which the Institute will process the payment

11. The delivery of the items under this contract shall be governed by the provisions outlined in Clauses 7, 8, 9, and 10 above.

12. The bidder shall declare that the goods supplied under this contract shall be the best in qual ity and workmanship and shall be strictly in accordance with the specifications and particulars c ontained in the GeM contract. Any fungus or foreign materials or other particles found in the ite m will lead to rejection of supply and other suitable actions. The successful bidder should guaran tee that the goods would continue to conform to the description and quality aforesaid for the per iod of contract. Notwithstanding the fact that SCTIMST may have inspected and approved the sai d goods, at any time during the aforesaid period of contract, SCTIMST will be entitled to reject th e said goods or such portion thereof as may be discovered not adhering to the said description a nd quality. On such rejection of goods shall apply. The supplier if so called upon to do should, r eplace the goods or such portion thereof as is rejected by SCTIMST. Otherwise the Supplier shall pay to SCTIMST such damages as may arise by reason of the condition herein contained.

13. In case the supplier defaults in the due supply of all or any of the articles correctly and prom ptly, SCTIMST is at liberty to procure the same from elsewhere without cancelling the contract a s a whole. If higher cost than the agreed rate is incurred by SCTIMST in such procurements, the excess cost may be deducted from the supplier bill or adjusted or otherwise realized from securi ty deposit or recovered from by other means.

14. The successful bidder shall not assign or make over in part or wholly, the contract or the ben efits or burden thereof. The supplier shall not underlet or sublet the execution of the contract or any part thereof. SCTIMST will have absolute power to refuse such consent or rescind the conse nt at any time. The supplier shall not be relieved from his/ her obligation, duty or responsibility under this contract, even if consent to let or sublet is given by SCTIMST.

15. If at any time during the course of the contract, it is found that any information furnished by the supplier to SCTIMST, either in this tender or otherwise, is false, SCTIMST may put an end to t he contract wholly or in part and it shall be lawful for SCTIMST to forfeit the amount deposited b y the supplier as security deposit and cancel the contract. It shall be lawful for SCTIMST to set off any loss or expense, cost or damages, sustained or incurred due to the cancellation of the contract from and out of the money for the time being payable or due to the supplier.

16. The rate offered by the bidder must be equal to or lower than the rate offered by any Centra I or State Government Organization, PSU, or Public Listed Company in Kerala State for the same quantity specified in the bid document. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
