4. The Contractor/Vendor/Agency shall sign and stamp each page of the tender document thereby ensuring the number and sequence of all pages.

5. No conditions other than mentioned in the tender will be considered.

 Sealed tender should be superscripted as "Tender for Hiring of Third Party Inspection Agency- Availing License for passenger lift". Late tenders will not be accepted.

7. The Director of the Institute reserves the right to terminate the maintenance contract at any time after giving due notice without citing any reason. The contractor will not be entitled to claim any compensation against termination.

8. The successful tenderer will be required to work as per the guidance of Division of Clinical Engineering, SCTIMST.

9. The contractor has to provide supervisory and management support by his own staff to get lift licence.

TERMS AND CONDITIONS

1. Eligibility Criteria

- 1.1. The bidder must have prior experience in handling lift licensing processes as per Kerala Lifts and Escalators Rules, 2012.
- 1.2. The bidder must have a valid registration under relevant government authorities and a valid license from Kerala State Electrical Inspectorate.
- 1.3. The bidder must provide references or completion certificates for at least three similar projects in the past two years.

2. The bidder is responsible for:

- 2.1. Conducting a review of the five installed lifts.
- 2.2. The lift panels in Swasthy, Srishty and NFH block require regularization process for the lifts installed. The bidder shall consider the same in the quote. In addition, any such deficiency that relates to the documents required for submitting the application shall be clarified by visiting the site and preparation of the same shall be included in the scope of the bid. The quoted rate shall be inclusive of preparation of all such required documents for the bid.
- 2.3. Coordinating inspections and obtaining required documents if any from SCTIMST and Lift vendors.
- 2.4. Preparing and submitting all necessary applications, drawings and supporting documents to the Electrical Inspectorate for availing a valid lift license for the 5 lifts.
- 2.5. Ensuring rectification of any deficiencies flagged during the inspection.
- 2.6. Liasoning with authorities to secure the lift licenses <u>including payment of statutory</u> <u>fees</u>, preparing required clarifications and related documents.
- 2.7. Ensuring the issuance of licenses for all five lifts as per the statutory requirements.

3. Deliverables

3.1. Lift licenses for all five lifts issued by the Electrical Inspectorate shall be obtained.

4. Period for completion

- 4.1. The entire process, including obtaining licenses for all five lifts, must be completed within <u>8 weeks</u> from the date of awarding the contract.
- 4.2. Any delay beyond the agreed timeline without valid justification will attract a penalty of 0.5% of the total contract value per week, up to a maximum of 10% of the contract value.

5. Bid Submission Requirements: Single cover bid with the following:

- 5.1. Technical Proposal:
 - 5.1.1. Description of prior experience.
 - 5.1.2. Details of key personnel involved.
 - 5.1.3. Proof of previous experience in lift licensing.

- 5.1.5. GST and PAN details.
- 5.2. Financial Proposal:
 - 5.2.1. Lump-sum price for the complete scope of work for each lift and total cost for the five lifts.
 - 5.2.2. Breakdown of statutory fees (if applicable).

6. Payment Terms

6.1. Payment will be released after the completion of scope of work and handing over the license to SCTIMST.

7. General Conditions

- 7.1. The bidder will not subcontract the work without prior approval.
- 7.2. The bidder shall visit the site and familiarize about the scope of work prior to submission of bid.
- 7.3. Further information or clarification, if required, can be had from the Division of Clinical Engineering.
