- 5. The service provider has to ensure that the reservation policy of DoPT, Govt. of India to be followed, if applicable.

6.	All contract staff on duty will report to an officer nominated by the Institute.
7.	Reliever/ additional man power should be provided by the service provider, if required.
8.	There is no employer – employee relationship between the Institute and the personnel engaged/deployed by the contractor and as such any misconduct by them on information given by the Institute shall be dealt with the contract or and action taken. 15.	The antecedents of all of its staff (including relievers) will be got verified fro m the Police Authorities by the Service Provider before deployment for work and copy of report (Police Verification Certificate) should be submitted to the Institute within fifteen days from the date of the contract. If there is a replace ment done during the period of the contract, the Police Verification of the ne w deployment also be submitted mandatorily. Copy of bio data of all of its st aff (including relievers) should be provided to Personnel& Administrative Div ision of the Institute.
16.	The service provider shall ensure every staff deployed at the Institute agains t the contract is medically fit and should obtain Medical fitness certificate fro m each staff (including the relievers) and submit to the Institute.
17.	The service provider shall ensure that no personnel engaged / deployed by h im will engage in any type of activities prejudicial to the interest of the Instit ute.
18.	The Service Provider/ Contractor shall be liable for any unlawful activities by the workers deployed by him / them to SCTIMST under this tender

19.	The Service Provider/Contractor shall maintain proper records about the atte ndance of their staff in the prescribed format as given in the Contract Labour (Regulation and Abolition) Act, 1970 along with Contract Labour (Regulation and Abolition) Rules, 1971 and would ensure that full staff strength is mainta ined. If due to any exigency, any worker is absent the Service Provider/ Cont ractor should take immediate steps to provide its substitute subject to the compliance of relevant Rules & regulations/laws/ Statute. Necessary fine shall be imposed for the violation.
20.	Biometric punching of attendance to be arranged by the service provider for all the contract staff deployed by them on their own cost, if required.

25.	In case of any changes in the minimum wages or any statutory wage compon ent as per the applicable laws during the contract period, Institute shall pay the service provider, the differential amount in wage. Such increase in the wages will not have any impact on the service charges.
26.	The Service Provider/Contractor will deduct ESI contribution and Provident fu nd contribution of the employees from the minimum wages of the workers at the rate as applicable from time to time and deposit the same with the appro priate authorities along with Employer's contribution of ESI and PF as per the statutory rate applicable from time to time, if applicable.
27.	The applicability and rates of employer contribution of ESI and EPF will be de cided as per the Employees Provident Fund Act, 1952 & Employees' State Ins urance Act, 1948 and its subsequent amendments. Employees of the service provider who are covered under any other health benefit scheme of Gol/GoK shall not be covered under the ESI, if applicable.
28.	The applicability of Bonus will be decided as per The Payment of Bonus (Ame ndment) Act, 2015, if applicable.
29.	The Service Provider/ Contractor will be liable to get the Provident fund refun ded from the Provident Fund Commissioner of the worker, if he is terminated or dies or leaves the job

30.	Payment of bills will also be regularized subject to the rendering of satisfacto ry service during the month and deduction of Penalty imposed, if any, as per terms and conditions of tender/contract.
