If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. - 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

Design concept & scope of work

(i) Design concept

The entire IP surveillance system is designed to control and monitor the different building blocks of the SCTIMST Hospital and Kumarapuram Quarters/Hostel campuses. All the corridors shall have I P Fixed dome/bulletcameras to monitor the connecting corridors either in wall or on pole. Optical fixer / CAT 6 cable shall be laid through HDPE /PVC Piper/ ground/ clamping along walls from the ne arest OFC available point by installing Outdoor/Indoor wall mounting rack, Polycarbonate junction box, SFU modules, POE switches, MCBs, lighting arrestor, surge protector, earthing, UPS, etc.

Two types of cameras shall be installed to monitor the movement of the people as follows:

- · IP fixed HD camera (dome/bullet) indoor type.
- · IP fixed camera(Box/Bullet) outdoor type.

IP fixed dome/bullet indoorcameras shall be installed at the entrances of various sections and con necting corridors of the various Buildings. IP-fixed outdoor cameras shall be mounted on the building corner areas or on poles at different locations for outside surveillance.

All IP Camera Should have the following functionalities

- · All cameras shall be true IP camera.
- · All outdoor cameras shall be in IP-66 housing.
- · All outdoor Cameras and Accessories should be water proof and dust proof housing.
- · All cameras should have PoE (Power over Ethernet) feature.

(ii) Scope of work

- Supply, installation, testing, and commissioning high-quality IP surveillance Syst em along with power supply, power distribution, and required accessories in different block s(Block 1, Block 2, Block 3 and AMC Block) of SCTIMST Hospital campus and Kumarapuram Quarters/Hostel as indicated in BOQ.
- The entire system shall be as per BOQ and technical specifications enclosed with h this RFP document. Bids must be complete with all equipment and required accessories.
- The price quoted by the vendor should include all the expenses incurred in the s upply, installation, and commissioning of all Cameras with power supply, accessories, and other devices complete with software.
- The IP surveillance system should consist of IP Fixed dome/bullet cameras (indo

or type), BOX/BULLET (Outdoor type), software, storage system, network racks, network sw itches, TV screens, workstation, power supply, and necessary mounting and fitting hardwar e, plugs, sockets etc. as required for complete installation of the system under this bid in fo ur stages

- Video management software shall offer both video stream management and vid eo stream storage management. Frame rate should be considered between 25 to 30 fps fo r High-definition Recording. Frame rate and resolution for individual channels shall be programmable.
- · Backup as evidence for 90 days.
- The system is presently designed for 300 cameras and is scalable for up to 400 cameras if required in the future.
- Racks should be supplied and installed in appropriate places in Hospital Buildings and Ku marapuram Quarters/Hostel campus.
- The cable laying work from IP Camera to the Nearest Network CCTV Rack is in the Scope of Bidder.
- The bidder should provide the cable laying cost per meter and fixing pole charges in the financial documents.
- · All camera Power supply unit (PoE) is connected to SCTIMST's existing POE switch/newly supplied POE Switch.
- · Training & handing over of all materials, equipment, and appliances.
- · No extra cost shall be paid for miscellaneous items required to complete the work as per t he design concept.
- Provide any other items/accessories required for installation, testing, and commissioning of the IP surveillance System within the scope of the bidder.
- Provide supervisory specialists and technicians at the job to assist in all phases including s ystem Installation, start-up and commissioning. This will include fixing of camera using a su itable camera mount (as per site requirement) complete with required civil and fabrication works, creating the backbone for the system by laying the required data and power cables, termination/splicing of all cables, fixing cable trays, conduits, installation and commissionin g of all items supplied under CCTV system as required basis.
- Mounting & installation of Servers/NVR, Rack recording/storage devices, viewing stations, and connecting to the network.
- · Integrating the whole system for optimum performance.
- The proposed Cameras at Gates will be installed on dedicated poles for this purpose. The f ixed cameras at various sections are to be installed on walls or on Trusses where walls are not available, using proper mounting brackets complete with Fasteners, clamps to support the required load and pipes duly painted and finished.
- Erection and commissioning of networking e.g., cables (UTP/OFC shall be laid through HD PE/PVC pipe/ground/ clamping along walls from the nearest available point) and connection s to be provided by installing outdoor/indoor wall mounting rack, poly carbonate junction b ox, SFU modules, POE switches, patch chords, network panels, Lightning arrestor, surge pr otector, earthing etc.to be provided.
- Termination and testing of OFC (Optical fibre cable) (all cores).

- The bidder shall bear full responsibility for all kinds of maintenance which include periodic maintenance as well as attending to all break-down and emergency calls at short notice wh enever called during the warranty and CMC period.
- · All equipment and components supplied shall be new and of manufacturer's current mode I.
- · All equipment and components shall be installed in strict compliance with manufacturers' r ecommendations and as per the standards in vogue. Also, the firm shall consult the manufa cturer's installation manuals for all wiring diagrams, schematics, physical equipment sizes, etc., before beginning system installation.
- The bidder shall design the system and its complete layout as per the defined quantities in various sections of this tender document. (layout positioning cameras and its accessories in an Autocad or latest format.). All cameras should be integrated in the as built layouts and the same should be configured to display for easy location identification. Vendors should ensure the coverage and quality footages of each area as a part of commissioning. Prepare and submit detailed performance data of various system modules and drawings, detailed selection and drawings of various devices, wiring drawings and details and makes of OF C/Power cables and wires.
- The bidder/OEM is required to demonstrate the CCTV camera DORI conditions on behalf of technical committee during the technical evaluation of the bid.
- The successful firm will have to provide complete manufacturer's specifications for all ite ms that are to be supplied. Including vendor name, for every item to be supplied, part num ber, model number etc. in detail. The firm on whom the Purchase Order will be placed will h ave to get all the supplied material as per the Purchase Order and then only the execution shall start.
