2. The price quoted by the firm should show separately basic maintenance charges per item per annum and GST rates.
3. The firm should attend **Four Preventive maintenance** visit in a year (once in three months) and unlimited break down calls without any additional charges.
4. Before offering the tender, the intending firms may inspect the existing equipment on any working day with prior appointment with Engineer, DCE.
5. It shall be responsibility of the Contractors/Vendors/Agencies to arrange and ensure that all pages of the bid are properly bound separately. Tenders in loose pages may be disqualified.
6. The Contractor/Vendor/Agency shall sign and stamp each page of the tender document thereby ensuring the number and sequence of all pages.
7. No conditions other than mentioned in the tender will be considered.
8. Sealed tender should be superscripted as "**Tender for Annual Maintenance Contract of Air Conditioning Equipment**". Late tenders will not be accepted.
9. The Director of the Institute reserves the right to terminate the maintenance contract at any time after giving due notice without citing any reason. The contractor will not be entitled to claim any compensation against termination.
10. There would be no increase in rates payable to the contractor during the contract period.
11. The successful tenderer will be required to maintain the systems with the original spares/consumables and as per the guidance of Division of Clinical Engineering, SCTIMST.
12. The contractor has to provide all tools and tackles etc. required for the work.
13. The contractor has to provide supervisory and management support by his own staff to get maximum output and all the works should be carried out through qualified

16. Bidders should have a minimum of three years of experience in the service/maintenance of Air-Conditioners (Window, Split, Cassette, Ductable and Cold Room) to various organizations.

TERMS AND CONDITIONS FOR AMC (COMPREHENSIVE)

1. Service Charges

Comprehensive AMC charges include the cost of labour, spare parts, accessories, spares and Consumables.

2. Period

The contract shall remain in force for one year. The renewal after the completion of each year will only be done on receipt of satisfactory service report and recommendation for the same from the head of department concerned and the DCE.

3. Taxes and Duties

Since it is AMC/ Service charges, the above mentioned value is inclusive of all taxes, except GST. GST if any applicable will be paid extra as per rules. TDS at appropriate rate shall be made from the service charges as applicable.

4. Payment

Payment would be released on satisfactory completion of service as per the scheduled visit during the period of AMC, on half yearly/ Yearly (after service). The release of payment is subject to the satisfactory report from DCE

No advance payment would be made.

5. Preventive Maintenance & Schedule of Visit

- i. The contractor shall ensure the preventive maintenance of equipments. The representative of the contractor shall visit the Institute **Four times (once in Three months)** in a year for preventive maintenance which will include water washing of filter, drain tray and pipe cleaning, evaporator brush cleaning, oiling/greasing of all fans, carrying out necessary repairs, checking of current consumption and general – performance of the equipment, testing of gas pressure if necessary, water washing of condenser coil etc and will attend any number of breakdown calls reported to them without charging any additional fee. Schedule of visit to be fixed jointly by the contractor and the concerned Engineer of Division of Clinical Engineering of the Institute.
- ii. The required tools and plants for carrying out the work shall have to be arranged by the Contractor at his cost and no tools will be arranged by SCTIMST. The Contractor shall keep all required tools at site.
- iii. Details of all minor/major, routine/preventive repair/maintenance job undertaken shall be entered into the history sheet.

- iv. A record of preventive maintenance carried out would be maintained by the contractor and duly certified by the authorized officer. The contractor shall maintain history sheet of equipments under maintenance contract with detailed specification.
- v. The contractor shall arrange to render efficient service as outlined in this specification. However, in case the contractor fails to maintain the service to the satisfaction of the Engineer-in - charge of the department and any expenditure incurred therein for alternative arrangements by the Engineer-in-charge shall be recovered from the contractor.
- vi. The contractor shall deploy more technicians in case of heavy workload, to undertake preventive maintenance schedules of all the ACs in the various buildings.
- vii. It is the primary duty of the successful contractor to ensure that all air-conditioners under the contract are in working condition including those in unmanned area such as Server Room, UPS Room etc. Hence the contractor should monitor and daily inspect all air-conditioners in unmanned areas of Office. Necessary space will be provided to them to maintain the spares, tackles and tools and registers required for carrying out the AMC works.
- viii. All the Air-conditioners covered in this contract have to be maintained as per the standards of the original manufacturing company. The contractor has to repair /service/ maintain the air conditioners under the AMC in as is where is condition when handed over to them under AMC. The Institute has installed its own transformer for the site premises; hence the power supply is stable and is well regulated. The institute will not admit any claim from the contractor that the fault/damage is caused due to quality of power supply and it will not absolve the responsibility of the contractor in rectifying the fault.
- ix. The Contractor workmen are required to report to the concerned staff in charge of the Air Conditioning plant for specific directions/intimations before attending breakdown and preventive maintenance. The contractor shall provide a single telephone number with 24 x 7 service support. The contractor shall also provide service in response to oral including telephonic notice by the SCTIMST whenever necessary. No supervision will be provided by the institute for any works. The Bidder is solely responsible to ensure that no accident / damages occur to the installations / personnel during the operation and maintenance work.
- x. All debris resulted out of performing the work has to be removed out of SCTIMST's premises and disposed as directed by Municipality / Corporation authorities immediately after completion of the job. No bills will be considered before such site clearance. If any repair is carried out, the waste created during such repairs like cartons, boxes, broken pieces of wires, tapes, and such other material etc., shall be immediately removed out of site by the contractor as it creates a fire hazard. The SCTIMST's saleable scrapped materials shall be kept by contractor in place designated for it by the institute.
- xi. The contractor personnel shall take seasonal precautions, to protect the electrical installation. All the works should be carried out through qualified technicians only.

- xii. The Contractor shall provide and ensure sufficient personal protection gears like safety shoes, hand gloves, full body safety belts, ladders, umbrella, rain coat, temporary platform, first-aid box, etc. are being used by their workers while carrying out works. The Contractor alone shall be fully responsible for safety and security & insurance or life insurance of their personnel who are working at site.
- xiii. The Technicians shall report to the Security while entering & exiting the premises. All personnel of Contractor will be subjected to a thorough physical checking while coming and leaving the building. Those persons so deputed will sign in the Register for arrival and departure at the site. Only persons with valid gate pass issued by SCTIMST will be allowed to enter the premises.
- xiv. Whenever technicians are attending to repairs and services, the information of location where repairs and services of air conditioners is being carried out must be recorded in the Movement Register existing in plant room along with time at which they have left. On returning back the same need to be recorded.
- a. Works to be carried out monthly
- Cleaning of filters of all the air conditioners to conserve the energy and checking of current drawn by each AC to know the healthy condition of the ACs
 - Cleaning of filters, outdoor and indoor units.
 - Checking and tightening all electrical connections
 - Checking for condensate drain in particular, from indoor unit of package/split/cassette AC and remove the blockage and repair leakages, if any
 - Repairing, etc is to be done immediately if on inspection any defect is found
- b. Works to be carried out at quarterly PM visits
- Checking motor bushings
 - Ground connections
 - Checking connections at the main plug
 - Cleaning of blower and condenser fan
 - Cleaning the evaporator and condenser coils cleaning the equipment'
 - Checking and tightening of nuts and bolts
 - Oiling the motors
 - Checking cooling efficiency
 - Overhauling of the A/c with chemical washing process
 - Cleaning the condenser and evaporator coils with suitable detergent/chemical solution and flushing with high -pressure jet of water
 - Greasing of blower motors and all moving parts
 - However, the air filter of the AC units shall be cleaned every month of the quarter
 - Check the compressor and its spare parts, compressor motors and its coupling

6. Place

The place of maintenance of the equipments will be the installation site at SCTIMST. In the event of any major breakdown and if repairs cannot be done at the Institute, the defects can be rectified at any service centre as the contractor may think proper after approval of the Medical Superintendent of the Institute on recommendation of DCE. But dismantling, packing, forwarding, transportation and insurance charges etc., if any, would be borne by the contractor. Gate pass for temporary removal of equipments / spares shall be obtained from the contractor **and the contractor shall provide a replacement unit till the time the machine sent for repairs is positioned back.**

7. Termination of Contract

SCTIMST reserves the right to terminate the contract on unsatisfactory performance of the contractor during the period of contract by giving one month notice in writing without any financial commitment to the Institute. However, the contractor shall continue to render satisfactory service for the balance period till alternate arrangement is made by the Institute.

8. Scope

The equipments covered under this contract shall be repaired and rectified on site during the office hours of the first party (08.00 AM to 04.00 PM on all working days) as and when the same is reported to be out of order. (Emergency – out of office hours) The cost of genuine/original spares/consumables/accessories required for maintenance shall be borne by the contractor.

The service engineer of the contractor should report to DCE and collect work permit from the concerned engineer in charge of the equipment before commencement of the work. After completion of the work the service engineer should get the comments regarding the service and signature from the user on the space provided for obtaining 'remarks by user department' in the work permit. The service engineer shall submit the service report and the work permit of the work done during each visit, to the DCE and record the same in a logbook.

Replacement and repairs of compressors, condenser coil, evaporator coil, gas charging, air filter, electrical parts, servicing overhauling, greasing, starting relay, overload protector, wiring repairs, motor rewinding with bush and shaft, tapes including handling charges, blower motor/outdoor fan motor, digital scanner, piping, insulation and spare of out door/indoor unit replacement, starting capacitors, running capacitors, condensers, relays, thermostats, fan capacitors, fan motors, selector switches, power contractors, control contractors, rewinding of motors, providing ball bearing of motors, fan blades, electronic control circuitry, control panel, remote control units, PCB, drain pump, float switch etc. complete in all respects, for ensuring the desired levels of cooling shall be done by the contractor in consultation with concerned Engineer. It shall be responsibility of the contractor to provide authorized price list of spare parts / consumables / accessories of the equipment covered under Annual Maintenance Contract from his Principals. Any item requiring

replacement for which there is no mention in the price list, the contractor shall provide them free of cost.

Any damage to the building or any part of the equipment which might result during the operation shall be repaired by the contractor.

Defective spares compressors / condensers are to be replaced with new compressors / condensers and repairing of the old compressors is not permitted. Whenever new compressors / condensers are used, the Contractor has to produce original invoice and warranty card of the new compressor/ condenser at the discretion of SCTIMST. The compressor/ condenser being replaced should match with the original star rating of the air conditioner.

After completion of work, the debris material shall be removed from site and stored in the designated area meant for scrap materials within the Institute by the contractor.

9. Performance security

Successful tenderer shall enter into an agreement and shall produce a bank guarantee or security deposit (in the form of account payee demand draft or fixed deposit receipt from a commercial bank) should be submitted as performance security by the contractor to the Institute. The bank guarantee should be from a nationalised bank of India in a format approved by the Institute and should have validity till 3 months after the expiry of the contract period. The amount of the performance security should be 2.5% of the value of the contract. In the event of non compliance of tender conditions, Performance security shall be forfeited.

10. AMC charges on pro rata basis will be given to Air Conditioning units which shall be added after its warranty period.

11. Down Time and Penalty Clause for Comprehensive AMC

Up-time means 95% of total days in a year during which the equipment remains functional. Down time means any shortage in achieving the up-time. In the case of Comprehensive Annual Maintenance Contract, it will be the responsibility of the contractor to set right the equipment and avoid downtime. Downtime penalty shall be imposed at the rate of 0.5% of the Annual Maintenance Contract charge per day which shall be recovered from the contractor.

In cases where the auxiliary units/ components attached to the main equipment undergo failure, and the main equipment provides uninterrupted services, there shall be separate down time calculation for the auxiliary units/ components. Penalty in such cases shall be at the rate of 0.1% of the annual maintenance contract charges per day.

12. Arbitration

In the event of breach of any condition in this contract, the matter would be resolved jointly by Medical Superintendent, Heads of Departments /DCE/FA/AMO of the Institute and representative of the Contractor.

13. Assignment

The contractor shall not assign the job or part of the contract to any other firm without the consent of the Institute in writing

14. Breakdown Notice to the Contractor

The breakdown details would be reported to the Service Engineer / office of the contractor by the DCE Engineer through the fastest mode of communication (by phone) which shall be confirmed in writing (By Fax/Registered letter).

Complaints regarding the non functioning of air conditioners are to be attended within three hours from the time of reporting the complaint. In case of minor technical problems same are to be rectified within one hour of diagnosing of complaint. In case of major technical problems, the same are to be rectified within 48hrs after the receipt of the break down report.

All break-down calls shall be attended immediately and on the same day. The contractor shall ensure that round the clock breakdown calls are attended immediately including Sundays and holidays.

15. Service Report

Service report for each visit (Routine as well as breakdown services) duly certified by the HOD concerned/ Nominee of HOD must be submitted to the DCE engineer along with the work permit issued from DCE after attending the work.

Name of the Department/Division/Section, Equipment Name, Equipment Code/Tag No., Nature of service (PM/BM), date of service (PM/BM) should be clearly mentioned in the Service Report.

16. Fall Clause

The maintenance charges shall in no event exceed the lowest charges at which second party service machines of identical description to any other party during the period of this contract. If at any time, during the said period, second party reduces the service charges, of such machines to any other customers, it shall be forthwith notified to first party and the charges payable under the contract for the servicing done after the date of coming into force of such reduction of servicing charges shall stand correspondingly reduced.
